To delete the propositions and to substitute therefor:

- “1. That the remuneration and allowances package paid to States Members and Non-States Members of Departments and Committees with effect from 1 May 2012 until 30 April 2016 shall be identical in all respects to that payable to States Members and Non-States Members of Departments and Committees in respect of the 2008-12 term of the States in accordance with Resolutions 1 and 2 on Article 9 of Billet d'État No. II of 2008.*
- 2. To direct the Policy Council:*
 - (a) to investigate the desirability of replacing with effect from 1 May 2016 the existing defined benefits pension scheme for States Members with a States Members' money purchase pension scheme or such other pension provision for States Members which is less dependent on the amount being paid into the fund by way of contributions from the States of Guernsey, and*
 - (b) to undertake a thorough review of the remuneration and allowances package paid to States Members and Non-States Members of Departments and Committees,**and to report thereon to the States by no later than May 2014.*
- 3. To direct the Treasury and Resources Department to develop a detailed policy specifying the IT equipment and software that should be made available to States Members including the provision of secure email; such policy to be based upon the principles established by the Independent Panel.”*
