To add the following paragraph:

- “(c) insert at the end of the words in sub-paragraph (2)(a): “except that for the purpose of the election of a Chief Minister voting shall be by appel nominal””.

Explanatory Note

Rule 20(2)(a) provides that where in any election the number of candidates exceeds the number of vacancies voting shall be carried out by secret ballot. The effect of this amendment is that members will be invited to name the candidate of their choice in the same way as for a normal appel nominal, but substituting the name for “pour” or “contre”. Any member might, of course abstain by responding “je ne vote pas”.

To add the following paragraph:

- “(c) insert at the end of the words in sub-paragraph (2)(a): “, save that in elections for the office of Chief Minister the Greffier shall publish as soon as possible thereafter a list detailing the vote cast by each Member of the States””.

Explanatory Note

Rule 20(2)(a) provides that where in any election the number of candidates exceeds the number of vacancies voting shall be carried out by secret ballot. The effect of this amendment, which replicates a proposal made by the Committee in January 2012, is that members' votes will be made public.
