

E40 EMPLOYEES ON SECONDMENT (section 8)

A. Short term secondments

Normally any remuneration of employees carrying out duties in Guernsey would be taxable and subject to deduction of Guernsey income tax under the Employees Tax Instalment Scheme, unless the provisions of a Double Tax Arrangement (“DTA”) provide otherwise.

Notwithstanding the above, with effect from 1 January 2008, the remuneration of an employee seconded to Guernsey may be regarded as exempt from Guernsey income tax if all of the following conditions apply:

- (a) the secondee is in Guernsey in the year of charge for 90 days or less;
- (b) the secondee continues to be remunerated by the overseas employer;
- (c) the costs of remunerating the secondee, including associated costs such as travel and accommodation, are not allowable to the Guernsey employer, whether paid directly or by reimbursement to the overseas employer.

B. Seconded education professionals, not falling within A. above

With effect from 1 January 2014, this Statement of Practice has been extended to cover professors, lecturers, teachers and researchers, as follows:

A professor, teacher, lecturer or researcher, who makes a temporary visit to Guernsey for a period not exceeding two years, for the purpose of teaching or carrying out research at an educational institution, which is recognised for that purpose by the Education Department, and who is, or immediately before such visit was, a resident of another jurisdiction shall, in respect of any remuneration for such teaching or research, be exempt from tax in Guernsey, provided that such remuneration arises from sources outside of Guernsey.

This concession shall not apply to income from research activities, if such research is undertaken wholly or mainly for the private benefit of a specific person or persons.

For the avoidance of doubt, this part of this concession would not extend to any taxable payments which the individual concerned receives from the Education Department, or any recognised educational establishment in Guernsey, as referred to above (for example, the provision of, or contributions toward the cost of, accommodation, living expenses, etc), which will continue to be taxable in the normal way (and allowable to the employer, if relevant).

“An educational institution, which is recognised for that purpose by the Education Department” is a school or college in Guernsey, Alderney or Herm which is included in the Education Department’s list reproduced below.
