Direct Debit is recommended to you as a more convenient way of paying your contributions. Payment by Direct Debit can save you considerable time and effort – there are no cheques to write, paperwork, postage or queuing.

You are in Control

Once you've signed a Direct Debit instruction, payment of contributions will be arranged between Contributions and your bank or Building Society. But you are still in complete control. The arrangement will continue for as long as you like, saving you the trouble of writing out and sending off cheques.

You will always know in advance how much will be debited from your account and when. No money will be collected unless you have authorised it. Contributions will notify you of the amounts and dates of the payments and a regular check against your statement will reassure you that payments have been made correctly.

The Direct Debit Guarantee

If there is insufficient money in your account to pay a Direct Debit, the Direct Debit will be represented within a few days.

This Guarantee is offered by all banks and building societies that accept instructions to pay Direct Debits.

If there are any changes to the amount, date or frequency of your Direct Debit, Contributions will notify you 10 working days in advance of your account being debited or as otherwise agreed. If you request Contributions to collect a payment, confirmation of the amount and date will be given to you at the time of the request.

If an error is made in the payment of your Direct Debit, by Contributions or your bank or building society, you are entitled to a full and immediate refund of the amount paid from your bank or building society - If you receive a refund you are not entitled to, you must pay it back when Contributions asks you to.

Easy to Cancel

You can cancel a Direct Debit at any time by simply contacting your bank or building society. Written confirmation may be required. Please also notify us.

Payment Dates You will be able to choose between quarterly and monthly payments. If you are under pension age, payments will be due on the fifteenth day of the month following the quarter (or the fifteenth day of the following month if you have chosen to pay monthly). If you are over pension age, payments will be due on the last day of the month following the quarter (or the last day of the following month if you have chosen to pay monthly).

The Policy and Resources Committee will process any personal data which you provide, via this form, in accordance with the Data Protection (Bailiwick of Guernsey) Law, 2017.
