STATUTORY INSTRUMENTS LAID BEFORE THE STATES

The States of Deliberation have the power to annul the Statutory Instruments detailed below.

No.47 of 2016

THE DRIVING LICENCES (THEORY TEST) (GUERNSEY) REGULATIONS, 2016

In pursuance of Sections 2A(b) and 2B of the Motor Taxation and Licensing (Guernsey) Law, 1987 and Section 4A of the Driving Licences (Guernsey) Ordinance, 1995, as amended, The Driving Licences (Theory Test) (Guernsey) Regulations, 2016, made by the Committee *for the* Environment and Infrastructure, are laid before the States.

EXPLANATORY NOTE

These Regulations replace the Driving Licences (Guernsey) Theory Test Regulations, 2005, and subsequent regulations amending those regulations.

These Regulations prescribe the procedures and formalities for completing a theory test and in particular, they add a hazard perception part to the existing theory test.

These Regulations will come into force on 1st November, 2016.

THE AIR NAVIGATION (RESTRICTION OF FLYING) (BAILIWICK OF GUERNSEY) AIR DISPLAY REGULATIONS, 2016

In pursuance of Section 151 (4) of Air Navigation (Bailiwick of Guernsey) Law, 2012, The Air Navigation (Restriction of Flying) (Bailiwick of Guernsey) Air Display Regulations, 2016 made by the Director of Civil Aviation on 1st September 2016, are laid before the States.

EXPLANATORY NOTE

These regulations prohibit (subject to the granting of exemptions) all flights within four and a half miles of position:

between 0950 and 1225 hours UTC on the 8th September, 2016 by reason of an air display. They impose other restrictions on flying and the use of Guernsey Airport in order to enable the display to be undertaken safely.

These regulations came into effect on 7th September, 2016.

THE AIR NAVIGATION (RESTRICTION OF FLYING) (BAILIWICK OF GUERNSEY) ALDERNEY ROYAL AERO CLUB AIR RACING REGULATIONS, 2016

In pursuance of section 151 (4) of Air Navigation (Bailiwick of Guernsey) Law, 2012, The Air Navigation (Restriction of Flying) (Bailiwick of Guernsey) Alderney Royal Aero Club Air Racing Regulations, 2016 made by the Director of Civil Aviation on 1st September 2016, are laid before the States.

EXPLANATORY NOTE

These regulations came into effect on 19th September 2016.

No.44 of 2016

THE FINANCIAL SERVICES OMBUDSMAN (CASE FEE AND LEVIES) (BAILIWICK OF GUERNSEY) (AMENDMENT) ORDER, 2016

In pursuance of Section 27 (3) of the Financial Services Ombudsman (Bailiwick of Guernsey) Law, 2014, The Financial Services Ombudsman (Case Fee and Levies) (Bailiwick of Guernsey) (Amendment) Order, 2016 made by the Committee for Economic Development on 1st September 2016, is laid before the States.

EXPLANATORY NOTE

This Order amends the Financial Services Ombudsman (Case Fee and Levies) (Bailiwick of Guernsey) Order, 2015 ("the Order") in relation to the levy scheme prescribed by the Office of the Financial Services Ombudsman ("OFSO").

The amendments to the Order:

- postpone the ending of the equal splitting of the costs of OFSO between the Bailiwicks of Guernsey and Jersey from the end of 2016 to the end of 2018, and
- in such appropriate circumstances as may be prescribed in the levy scheme by OFSO, permit the service of a levy notice under Article 7 of the Order on a representative of a person from whom a levy will be demanded.

This Order came into force on the 1st day of September, 2016.
