

ORDINANCE LAID BEFORE THE STATES

THE AL-QAIDA (RESTRICTIVE MEASURES) (GUERNSEY) (AMENDMENT) ORDINANCE, 2016

In pursuance of the provisions of the proviso to Article 66A(1) of The Reform (Guernsey) Law, 1948, as amended, "The Al-Qaida (Restrictive Measures) (Guernsey) (Amendment) Ordinance, 2016", made by the Policy & Resources Committee on the 31st October, 2016, is laid before the States.

EXPLANATORY MEMORANDUM

This Ordinance is made under the European Communities (Implementation) (Bailiwick of Guernsey) Law, 1994 and amends the Al-Qaida (Restrictive Measures) (Guernsey) Ordinance, 2013 ("the 2013 Ordinance"). The 2013 Ordinance gives effect to EU Regulation No. 881/2002 which was enacted to implement certain United Nations measures imposing restrictions on the provision of assistance to the Al-Qaida network in respect of military and other activities, as well as targeted financial restrictions applicable to listed persons. The European Union has supplemented these restrictions with the introduction of its own autonomous sanctions regime in respect of legal or natural persons who are associated with ISIL (Da'esh) and Al-Qaida or any related cell, affiliate, splinter group or derivative. This regime is set out in Council Regulation (EU) No. 1686/2016 of the 20th September, 2016 ("the 2016 Regulation"). Association under the terms of the 2016 Regulation covers a wide range of activities, including support for or participation in terrorist acts, the provision of financing, technology, arms or training, engaging in trade (in particular oil, oil products and cultural property), travelling or seeking to travel into or outside the EU for the purposes of providing support, and recruiting or inciting the support of others. This Ordinance implements the 2016 Regulation in Guernsey.

The Ordinance was made by the Policy & Resources Committee in exercise of its powers under Article 66A(1) of the Reform (Guernsey) Law, 1948, and came into force on the 1st November, 2016. Under the proviso to Article 66A(1) of the Reform (Guernsey) Law, 1948, the States of Deliberation have the power to annul the Ordinance.

THE SOCIAL INSURANCE (BENEFITS) (AMENDMENT) REGULATIONS, 2016

In pursuance of Section 117 of the Social Insurance (Guernsey) Law, 1978, The Social Insurance (Benefits) (Amendment) Regulations, 2016, made by The Committee *for* Employment & Social Security on 25th October 2016, are laid before the States.

EXPLANATORY NOTE

These Regulations obligate an insured person who has an accident at work, for which they require hyperbaric treatment, to claim reimbursement of the cost of that treatment under any relevant policy of private personal accident insurance which they may hold, as a condition of any entitlement to industrial medical benefit. Among other uses, hyperbaric treatment is used to treat divers with decompression sickness.

These Regulations came into operation on 25th October, 2016.
