PLEASE NOTE:

- Traffic & Highways Services will determine the number of signs and/or cones required to safely sign the event. In addition, if the event is taking place on a main traffic route 'Advanced Warning' signs may be required from 6 days prior to the event to advise the public of traffic management measure. These signs would attract a separate charge to the main event signing.
- 2. Each event price includes the signs and/or cones being delivered and picked up once. Additional trips or changes may incur additional cost.

- 3. Dependant on the scale and number of attendees at your event, there may be a requirement to include HVM (Hostile Vehicle Mitigation) barriers where metal barriers will not be deemed sufficient. This charge will vary on a case by case basis and will be additional to the charges shown in the Traffic Sign Charges table above.
- 4. Where an event requires attendance both inside and outside of standard hours, the out of standard hours pricing only is used.
