This application form is issued by the Committee *for the* Environment & Infrastructure. Written permission is required by the Public Thoroughfares (Guernsey) Law 1958 before opening or breaking the surface, tunnelling under or boring into the any part of public highway.

Written permission is required regardless of whether or not an approved highway contractor undertakes the works.

Traffic and Highway Service's intention is that the legal requirement to obtain written permission is observed, that any works are undertaken in a safe manner, that the works are undertaken to Traffic and Highway Service's satisfaction (in terms of design, workmanship and materials) and that any works to alter the public highway do not adversely impact on the use of the public highway.

The information provided below may be disclosed to relevant Services of the States of Guernsey, made accessible to the public, published in the local media and on States of Guernsey managed websites.

5. Conditions

All work shall be undertaken in accordance with the "The Opening & Reinstatement of Guernsey Roads (2016)"

This can either be downloaded from http://www.gov.gg/excavationsinthepublichighway or a hard copy can be obtained from Traffic and Highway Services for a fee of £5.00.

Only highway contractors approved by Traffic and Highway Services can undertake works in the Public Highway, inclusive of both excavation and reinstatement works.

The reinstatement of the Public Highway must be guaranteed for 5 years following completion of the works or 3 years following the final resurfacing of any interim works.

A reinstatement consists of all the works required to make good the Public Highway, including the backfilling of any excavation, provision of any foundation layers and the relaying of the highway surface to match the existing.

Where equipment is to be placed in the public highway, records must be kept of its location by either submission of the details for inclusion on the Guernsey Joint Utilities Group (GJUG) web site (a £42.50 fee will be charged) or submission to an individual utility for inclusion within their records.

The owner must undertake to maintain the equipment and undertake any repairs to public highway that are due to the failure of that equipment at the owner's expense. The owner must ensure following any transfer of the property that the new owners accept the same undertaking.

Where any works to alter the public highway are designed to accommodate other works within private property, including changes to the thresholds between the public highway and private property, it should be noted that such changes to the Public Highway will not be permitted if they are believed to have an adverse impact on the use of the Public Highway. It is expected that, within the design of any private works, the threshold of the Public Highway will be taken into account.
