# Directorships held by me

- 1. Victory (Guernsey) Limited. The registered office is The Albany, South Esplanade, St Peter Port. This company owns Victory House, Le Pollet, St Peter Port (where the Petit Cafe is) which it rents out. It is a property owning company. I receive no remuneration as a Director. I and my wife own 50% of this company.
- 2&3. Lutine Insurance Holdings Limited and Lutine Holdings Limited. In each case the registered office is at the premises of Kleinwort Hambros in St Peter Port, Guernsey. I and my family have no beneficial interest in these companies. I do receive remuneration as a Director. I am a Director in my capacity as a Trustee. Lutine Insurance Holdings Ltd is a company which owns/operates an Insurance business outside the Bailiwick. Lutine Holdings Limited is the ultimate holding company for this small group of companies.
- 4. La Tourelle Limited. The registered office is at Les Granges de Beauvoir Manor, Ivy Gates, St Peter Port. It is a property owning company. It owns residential properties called La Tourelle at La Rue Traversee, Route de Cobo, Castel, and Manor View Bungalow, Ruette de la Tour, Castel, one of which is rented out. My wife and I own 100% of this company. I receive no remuneration as a Director.
- 5. Number One Limited. The registered office is at Les Hirondelles, Rue du Pre Bourdon, St Saviour, GY7 9JS. It owns offices at 1 Le Marchant Street, St Peter Port occupied by the law firm Mourant Ozannes and the adjacent/adjoining retail premises at Smith Street, St Peter Port, occupied by the Guernsey Press Company. It is a property owning company. Those premises are rented out. I own one-seventh of this company and I receive no remuneration as a Director.
- 6. The Scott Family PTC Limited. The registered office is at Mill House, St George's Esplanade, St Peter Port. It is a private run trust company. I am a Director in my professional capacity and I am remunerated as a Director.
- Ferchan Limited. Its registered office is at Warwick House, Le Pollet, St Peter Port. It is a trading company in the hospitality industry in Guernsey. The company is controlled/owned by my wife and members of my family. I receive no remuneration as a Director.
- 8. Rocquaine Properties Limited. Its registered office is at The Albany, South Esplanade, St Peter Port. It is a property owning company. It owns the Pearl Centre at Rocquaine, St Peters and the adjoining premises on the same site. These premises are rented out. The Pearl Centre to a private business and the adjoining premises to the States of Guernsey where

- they keep the maritime wreck. The company is owned 50% by myself and my wife. I receive no remuneration as a Director.
- 9. Balele Capital Partners Limited. Its registered office is at Somers House, Rue du Pré, St Peter Port. It is a service company. I own 10% of this company. I receive no remuneration as a Director.
- 10. Balele Capital Partners Limited, Balele Services Limited and Beauvoir Group Limited. The registered offices are at Somers House, Rue du Pré, St Peter Port. The Group operates a fiduciary business. I own 10% of this company. I receive no remuneration as a Director.
- 11. The Little Chapel Foundation. Its registered office is at Glategny Court, P O Box 140, Glategny Esplanade, St Peter Port, GY1 4EW. It is a charitable foundation whose purpose is to look after the Little Chapel. I am a Guardian thereof and I receive no remuneration.
- 12. Rich Man Poor Man Limited. The registered office is at Les Grandes de Beauvoir Manor, Ivy Gates, St Peter Port. It owns 'Arcachon', Bosq Lane, St Peter Port which is rented out as staff quarters. My wife and I own 100% of this company. She receives no remuneration as Director and is also the company's registered agent.

Directorships held by my wife Glenda Ferbrache. For ease of convenience I have carried on the numbering. The first company of which she is a Director is thus number 13.

- 13. Guernsey Building Developments Limited. The registered office is at The Albany, South Esplanade, St Peter Port. It is a property owning company. It owns the Manor Hotel, Petit Bot, Forest and a cottage on the opposite side of the road. These are rented out. My wife and I own one-third of this company. She receives no remuneration as a Director.
- 14. New Carlton (Hotel) Guernsey Limited. The registered office is at The Albany, South Esplanade, St Peter Port. It is a property owning company. It owns the Carlton Hotel/Inn, La Route des Cornus, St Martins. It is rented out. My wife and I own one-third of this company. She receives no remuneration as a Director.
- 15. Cranley Property Company Limited. The registered office as at The Albany, South Esplanade, St Peter Port. It owns residential properties opposite Valnord States Houses, the nearby late shopper at Collings Road, St Peter Port and residential properties leading down to the Water lanes. It is a property owning company. All the properties are rented out. My wife and I own one-quarter of this company. She receives no remuneration as a Director.
- 16. Rich Man Poor Man Limited. The registered office is at Les Granges de Beauvoir Manor, Ivy Gates, St Peter Port. See 12 above.

- 17. Holfer Limited. The registered office is at Warwick House, Le Pollet, St Peter Port. It is a property owning company. It owns Villa Restaurant, 35 Le Pollet, St Peter Port. It is rented out. It is 100% owned by myself and my wife. She receives no remuneration as a Director. She is also the Company's registered agent.
- 18. Rocquaine Properties Limited. See 8 above for details. My wife receives no remuneration as a Director.
- 19. Crabby Jack Holdings Limited. Its registered office is at Warwick House, Le Pollet, St Peter Port. It is a property owning company. It owns Crabby Jacks Restaurant and staff quarters at Vazon, Castel which is/are rented out. It is 100% owned by myself and my wife. She receives no remuneration as Director.
- 20. Capital Restaurants Limited. Its registered office is at Warwick House, Le Pollet, St Peter Port. It is a trading company. It operates a restaurant known as the Boathouse in St Peter Port which is leased from the States of Guernsey. The company owned as to 75% by myself and my wife. She receives no remuneration as Director.
- 21. Petal Limited is a property owning company. It owns and rents out a lodging house known as Petit Haven, Hauteville, St Peter Port. Its registered office is at Les Quatre Acres, Kings Mills, Castel. She receives no remuneration as a Director. It is owned 50% by myself and my wife.
- 22. Capital Restaurants Properties Limited. Its registered office is at Warwick House, Le Pollet, St Peter Port. It owns a property (a lodging house/staff quarters) known as Caledonia Lodge, Valnord, St Peter Port. It leases that property out. She receives no remuneration as a Director. It is owned 100% by myself and my wife. She is also the Company's registered agent.
- 23. Ferchan Limited. See 7 above for particulars. She receives no remuneration as a Director.
- 24. La Tourelle Limited. See 4 above for particulars. She receives no remuneration as a Director.

company. She receives no remuneration as a Director. She is also the Company's registered agent.

- 1. Les Granges de Beauvoir Manor, Ivy Gates, St Peter Port. This is jointly owned by myself and my wife. It is my principal residence.
- 2. The Vinery, Le Gele Road, Castel. This is jointly owned by myself and my wife. It is a commercial vinery and is rented out.
- 3. La Tourelle, La Rue Traversee, Route de Cobo, Castel. This is owned by La Tourelle Limited which is owned by my wife and I. It is a residential property.
- 4. Manor View Bungalow, Ruette de la Tour, Castel. This is owned by La Tourelle Ltd. It is rented/leased out. It is a residential property.
- 5. Ivymount, Mount Durand, St Peter Port. This is owned by myself and my wife as to an undivided one-half share, the other undivided share is owned by a third party.

For the avoidance of any doubt the only other real property in the Bailiwick owned by myself and my wife is as detailed in Appendix A and is represented by our shareholding in those various companies.
