## STATES OF GUERNSEY ECONOMIC DEVELOPMENT STRATEGY P.2018/48

- III. After consideration of the policy letter entitled 'States of Guernsey Economic Development Strategy' dated 18<sup>th</sup> May, 2018:-
- 1. To note that the States of Guernsey Economic Development Strategy set out in the Committee's policy letter builds on the Committee *for* Economic Development's policy plan, as approved by the States on 30<sup>th</sup> June, 2017, and the policies of the Policy & Resource Plan, as approved by the States on 8<sup>th</sup> November, 2017.
- 2. To approve the States of Guernsey Economic Development Strategy set out in the Committee's policy letter.
- 3. To direct the Committee *for* Economic Development to come back to the States by October 2018 with a report containing
  - a) an implementation plan (which will reflect the '20 actions to promote stronger growth' contained in Appendix 1 of the policy letter) and which clearly sets out an order of priority and time frames for reporting back to the States on all key work streams set out in that policy letter and
  - b) confirmation as to which policies and strategies the Committee *for* Economic Development will submit to the States for debate, together with respective timelines.

  - (c) To amend section 11 as set out in paragraph 3.7.
  - (d) To amend section 6 as set out in paragraph 3.8.
  - (e) To amend section 7 as set out in paragraph 3.9.
- 2. To note that Members of the States of Deliberation should be guided by the existing States' Whistleblowing Policy.
- 3. To adopt the guidance note entitled 'Anti-Bribery and Corruption Guidance for States Members and Employees' to cover all Members of the States of Deliberation.
