

**The Road Traffic (Speed Limits)  
(Amendment) (No. 3) Regulations, 2018**

THE COMMITTEE FOR THE ENVIRONMENT & INFRASTRUCTURE, in exercise of the powers conferred on it by section 2(2) and 8A of the Road Traffic (Speed Limits and Trials) Ordinance, 1987<sup>a</sup> and all other powers enabling it in that behalf, hereby makes the following Regulations:-

**Amendment of Part I of Schedule 1 to the 1987 Ordinance.**

1. In Part I of Schedule 1 to the Road Traffic (Speed Limits and Trials) Ordinance, 1987, at the end of paragraph 3(g) insert –

"Rue des Varendes, from the junction with L'Aumone to a point 55m east of the junction with L'Aumone,

Rue du Presbytere, from the junction with L'Aumone to a point 40m south of the junction with L'Aumone,

La Neuve Rue, from its junction with L'Aumone to its junction with  
Rue des Cauvains,

---

Ruette de la Croix,

Rue des Cauvains,

Rue de la Perruque, from a point 18m from its junction with  
L'Aumone to its junction with Les Vieux Beaucamps,

L'Aumone, from a point 40m west of the junction with Ruette Du  
Courtil Simon to its junction with Rue des Varendes,"

and at the end of paragraph 3, substitute a comma for the full stop and insert –


"(n) in the parish of Castel and Vale –

Rue Du Friquet, from the junction with L'Aumone to a point 100m  
from the junction with Rue Cohu."

**Citation and commencement.**

2. These Regulations may be cited as the Road Traffic (Speed Limits)  
(Amendment) (No.3) Regulations, 2018 and shall come into force on the 7<sup>th</sup> April,  
2019.

## EXPLANATORY NOTE

*(This note is not part of the Regulations)*

These Regulations, one in a series of ten statutory instruments, have the effect of introducing a 25m.p.h. speed limit in the roads specified therein. These Regulations affect roads around L'Aumone.
