AMENDMENT

Proposed by: Deputy D de G de Lisle Seconded by: Deputy B J E Paint

To replace "£450" as the Age-related allowance in Section 2 of the table in the First Schedule to Proposition 26 with "£950".

Explanatory note

The effect of this amendment would be to retain the Age-related allowance at £950 meaning that all taxpayers would receive a £500 increase in their personal income tax allowance. This would reduce budgeted revenues by £800,000 per annum and reduce the 2019 budgeted surplus to £200,000.
