Resignation as a Member of the Transport Licensing Authority

After careful consideration and discussion with the President of the Authority, I am writing to tender my resignation from the Transport Licensing Authority.

As I am also a member of two Committees which have a role in negotiating with airlines for the provision of air ambulance and medical evacuation services across the islands, I naturally wish to avoid this becoming an actual or perceived conflict with my responsibilities as a member of the Authority. After due reflection and discussion with my colleagues, I have concluded, with regret, that for the time being the best solution is for me to step down from the Transport Licensing Authority.

As I understand this letter will be published in the Billet d'Etat for the election of a successor, I hope you will allow me to take this opportunity to record my thanks to the President and fellow members of the Authority for their understanding, and for an enjoyable year working alongside them.
