Important Information

1. A 1968 IDP is valid for three years or until your driving licence expires, whichever is sooner. The expiry date is shown on the front of the IDP.
2. A 1926 and a 1949 IDP is valid for 12 months but may be subject to restrictions in certain countries if issued before 29th March 2019.
3. Photographs must:
 - be printed on photo quality paper on a plain background
 - be a passport type image of your head & shoulders
 - not include other people or objects
 - show your eyes open
 - be sharp and clear
 - not show reflection on spectacles if worn
