Licenced Pesticides

The following active ingredients have UK approval but can only be used under licence in Guernsey as they are considered a higher risk to people or the environment. The table below shows the products currently approved in the UK (April 2019).

Metaldehyde	Numerous		Slugs & Snails	UK approval for all products containing metaldehyde will cease from 30 June 2019 for sale and distribution & 30 June 2020 for the disposal, storage and use of existing stocks. UK approval will continue for use under permanent protection (glasshouses) but will require a licence for such use in Guernsey after 30 June 2020.
Oxamyl	Vydate 10G	16595	Root nematodes, stem & bulb nematode, Bemisia tabaci, Lyriomyza leaf miners.	Current UK approval for use on outdoor carrot (& protected carrot), fodder beet, parsnip (& protected parsnip), potato, sugar beet expires 31 December 2019. EAMU's for Outdoor ornamental plant production & Bulb onion, garlic and shallot.

EAMUs* (Extension of Approval for Minor Use) are at the Growers risk and can only be used under the conditions and rates specified in the EAMU and on the product label

Licencing of Products Approved in & Imported From Other EU Countries

Under certain circumstances products approved in other EU countries can also be considered for licencing. The product would need to be approved for the intended use in an EU country already. The following are examples which would be considered on that basis.

Imidacloprid	All UK products withdrawn		Approval in UK withdrawn in 2018 but still has EU approval for use as insecticide, in permanent greenhouses or for the treatment of seeds intended to be used only in permanent greenhouses. The resulting crop must stay within a permanent greenhouse during its entire life cycle.
Thiamethoxam	All UK products withdrawn		Approval in UK withdrawn in 2018 but still has EU approval for use as insecticide, in permanent greenhouses or for the treatment of seeds intended to be used only in permanent greenhouses. The resulting crop must stay within a permanent greenhouse during its entire life cycle.

Approved UK Pesticides But Prohibited in Guernsey

All products containing **Aluminium Phosphide**, **Aminopyralid** or **Picloram** are banned in Guernsey as they are considered to pose an unacceptably high risk to people or the wider environment.

The table below shows those products currently approved in the UK (April 2019) but prohibited in Guernsey.
