

COMMITTEE FOR THE ENVIRONMENT AND INFRASTRUCTURE

GENERAL IMPORT LICENCE 2022/01

This document has effect as an import licence for the purposes of paragraphs 6, 7 and 8 of Schedule 7 to the Import (Control) (Guernsey) Order, 2010, as amended.

This licence does not exempt a person who imports anything specified in this licence from the obligation to provide prior notification of such importation under The Official Controls (Brexit) (Amendment) (Bailiwick of Guernsey) Regulations, 2020, excluding non-commercial imports of pet dogs, cats and ferrets from Great Britain and the Crown Dependencies.

The States of Guernsey Committee *for the* Environment and Infrastructure authorises the importation of the following, subject to any specified conditions:

Live Animals

- 1.0 The animals specified below may be imported into Guernsey:
- 1.1 A pet cat accompanied by its owner or an authorised person, on condition that it is imported with no more than four other pet dogs, cats or ferrets and it is imported in accordance with the provisions of the Rabies Order, 2014;
- 1.2 A pet dog accompanied by its owner or an authorised person, other than a breed or type of dog specified in Annex 1, on condition that it is imported with no more than four other pet dogs, cats or ferrets; and it is imported in accordance with the provisions of the Rabies Order, 2014; and if it is imported from a country or territory other than the United Kingdom, Crown Dependencies, Republic of Ireland, Malta, Norway or Finland, it is treated against mature and immature intestinal forms of the *Echinococcus multilocularis* parasite within a period of not more than 120 hours (5 days) and not less than 24 hours (1 day) before the time of entry into the Islands and that such treatment:
- (a) is administered by a veterinarian and consists of a medicinal product that contains an appropriate dose of:
 - (i) praziquantel; or
 - (ii) pharmacologically active substances, which alone or in combination, have been proven to reduce the burden of mature and immature intestinal forms of the *Echinococcus multilocularis* parasite in the host species concerned;
 - (b) the said medicinal product has been granted:
 - (i) a marketing authorisation for use in Great Britain or a Member State of the European Community; or

- (ii) an approval or licence by the competent authority of the country or territory of provenance of such a dog; and
 - (c) is recorded by the veterinarian who administered the product in a pet passport issued in a part 1 listed country/Great Britain before 1 January 2021 or an Animal Health Certificate issued in the common travel area or a Great Britain pet health certificate.
- 1.3 a pet ferret accompanied by its owner or an authorised person, on condition that it is imported with no more than four other pet dogs, cats or ferrets; and it is imported in accordance with the provisions of the Rabies Order, 2014,
- 1.4 pet mouse, rat, rabbit, hamster, gerbil, guinea pig or chinchilla accompanied by its owner or an authorised person, on condition that it is imported in accordance with the provisions of the Rabies Order, 2014.
- 1.5 a Guernsey breed or first cross breed of bovine animal imported from Alderney or Sark, on condition that it:
- a) was:
 - i) born in, and has remained continuously since birth in, the island from which it is to be exported; or
 - ii) imported into the island from which it is to be exported from Guernsey and is being re-exported to Guernsey,
 - b) has been tested according to a standard equivalent to the requirements of the Animal Health Ordinance, 1996,
 - c) is identified according to the requirements specified in the Identification of Bovine Animals and Bovine Record Books Order, 2003; and
 - d) the island of exportation is not subject to notifiable disease restrictions,
- 1.6 a horse, donkey or mule imported into the Island from Great Britain or the Crown Dependencies, on condition that:
- a) it is transported directly to the Island from one of the said countries or territories, or in the case of the Isle of Man, via Great Britain, and
 - b) that the country or territory from which a horse, donkey or mule is dispatched, or through which is transported, is not subject to notifiable disease restrictions,
- 1.7 a pig, sheep or goat imported from the Channel Islands on condition that:
- a) it was born in, and has remained continuously since birth in, the island of from which it is to be exported; or

- b) it was legally imported into the island from which it is to be exported and has remained there continuously since its import; or
 - c) it was imported into the island from which it is to be exported from Guernsey and is being re-exported to Guernsey; and
 - d) the island from which it is being exported is not subject to notifiable disease restrictions,
- 1.8 poultry imported from Great Britain or the Crown Dependencies on condition that:
- a) they were born in, and have remained continuously since birth in the country or island from which they are to be exported; or
 - b) they were imported into the country or island from which they are to be exported from Guernsey and are being re-exported to Guernsey; and
 - c) the country, zone or island from which they are to be exported is not subject to restrictions in relation to Newcastle Disease or Avian Influenza,
- 1.9 hatching eggs of poultry imported from Great Britain or the Crown Dependencies on condition that they were:
- a) produced in the country or island from which they are to be exported; and
 - b) the country, zone or island from which they are to be exported is not subject to restrictions in relation to Newcastle Disease or Avian Influenza,
- 1.10 a pigeon imported from a Member State of the European Community or Northern Ireland, Great Britain or the Crown Dependencies on condition that it:
- a) it is accompanied by a certificate showing that it has been vaccinated against pigeon paramyxovirus type 1 (PPMV1); and
 - b) the country, territory or zone from which it is despatched or flown is not subject to restrictions in relation to Newcastle Disease or Avian Influenza,
- 1.11 a pet bird accompanied by its owner or an authorised person, specified in Part II of Annex 2, imported from a Member State of the European Community or Northern Ireland, Great Britain or the Crown Dependencies with no more than 19 other pet birds,
- 1.12 a captive bird imported from Great Britain or the Crown Dependencies provided that it is transported with no more than 19 other captive birds,
- 1.13 an animal specified in Part I of Annex 2, imported from a Member State of the European Community or Northern Ireland, Great Britain or the Crown Dependencies,

Bovine Semen, Ova and Embryos

- 2.0 Bovine semen, ova and embryos may be imported into Guernsey in accordance with the provisions of the Bovine Semen, Artificial Insemination and Embryo Transplantation Ordinances, 1957 to 2001.

Fertiliser

- 3.0 A fertilising product imported from a Member State of the European Community or Northern Ireland, Great Britain or the Crown Dependencies, provided that it complies with the requirements of Regulation 2019/1009.

Hay, Straw and Litter

- 4.0 Hay, straw and litter for use as bedding may be imported from a Member State of the European Community or Northern Ireland, Great Britain or the Crown Dependencies; on condition that the country or territory from which it is imported is not subject to notifiable disease restrictions.

Interpretation

- 5.0 For the purposes of this licence, the following definitions shall apply, unless the context requires otherwise –

“authorised person”	means any natural person who has authorisation in writing from the pet owner to carry out the non-commercial movement of the pet animal on behalf of the pet owner;
“bovine”	means an animal of the family Bovidae.
“captive bird”	means any birds, other than poultry, that are kept in captivity for any reason other than those referred to in the definition of “poultry”, including those that are kept for shows, races, exhibitions, competitions, breeding or selling;
“cat”	means <i>Felis catus</i> , excluding hybrids F1 to F4.
“crown dependencies”	means the Channel Islands and the Isle of Man.
“dog”	means <i>Canis lupus familiaris</i> , excluding hybrids F1 to F4.
“fertilising product”	means a substance, mixture, micro-organism or any other material, applied or intended to be applied on plants or their rhizosphere or on mushrooms or their mycosphere, or intended to constitute the rhizosphere or mycosphere, either on its own or mixed with another material, for the purpose of providing the

plants or mushrooms with nutrient or improving their nutrition efficiency;

"hay"	means any grass, clover, lucerne or sainfoin which has been dried either naturally or artificially and includes any product (other than grain) which is obtained by so drying any green cereal.
"litter"	includes any other substance or substrate commonly used for bedding or otherwise for or about animals.
"notifiable disease"	means any disease listed in Schedule I of The Animal Health Ordinance, 1998.
"pet"	means an animal which is kept for private non-commercial purposes.
"poultry"	means birds that are reared or kept in captivity for: (a) the production of: (i) meat; (ii) eggs for consumption; (iii) other products; (b) restocking supplies of game birds; (c) the purpose of breeding of birds used for the types of production referred to in points (a) and (b); with the exception of ratites and includes domestic fowl, turkeys, geese, ducks, guinea fowl, quail, pheasant and partridge.
"ratite"	means an animal of the families Struthionidae, Rheidae and Cassuariidae.
"Regulation 2019/1009"	means Regulation (EU) 2019/1009 of 5 June 2019 laying down rules on the making available on the market of EU fertilising products.
"straw" or	means any green cereal which has been dried either naturally or artificially and includes any product (other than grain) which is obtained by so drying any green cereal.

5.2 In this licence, unless the context requires otherwise –

- (a) a reference to any enactment or UK legislation is a reference to the enactment or legislation concerned as from time to time amended, varied, re-enacted (with or without modification), extended or applied,
- (b) a reference to any Community enactment or any provision or part of it, is a reference to the enactment provision, or part concerned as from time to time amended or re-issued (with or without modification).


5.3 Unless the context requires otherwise, an expression used in this import licence has the same meaning as in the Import (Control) (Guernsey) Order, 2010, as amended.
