And breathe © Well done for all your effort and hard work this week, we have seen some fantastic examples of resilience and flexibility as we've problem solved and supported each other, staff and families through into this next stage. Thank you.

Here are some updates and information for you.

1. The Stage 3 Requirements & Guidance

This is currently being reviewed by Education and Public Health and I hope to get that out to you as soon as it is agreed.

2. Staff Mental Health and Wellbeing support

The Educational Psychology Team have updated their support and guidance document to help us as we return to our settings. This is attached to this email and we would recommend sharing this with your team. As our childminders are lone workers and often by the nature of the leader/manager role please remember to take time for yourself. We are often better at giving advice to others than listening and taking it ourselves! \odot

3. Submitting Daily Attendance

Those providers who have been open in Stage one you no longer have to submit your daily numbers to SEYT from Stage 2 (March 8th)

4. Staff Testing - Providers who are currently open in Stage 1

We have seen a really positive response to the workforce screening. As you will be aware, many educational staff have been tested regularly over the past few weeks alongside our essential worker and vulnerable children. For the past three weeks there have been no positive cases related to any educational establishments. Children have continued to be tested this week and there continue to be no positive cases.

Following discussions with Public Health, there is confidence that there are no cases within the staff and children who have been mixing regularly in our settings throughout stage 1. For this reason, it is not considered necessary to test staff again this weekend. However, it is important that staff are tested towards the end of the week and over next weekend (11th-14th March) as this will follow a period of time where staff will have interacted with a much wider range of children, coupled with greater activity across the island. Please ensure to share this with your teams if you are currently open, to give some reassurance to your staff.

I will be in contact next week with <u>ALL</u> Preschool, day nurseries and childminders with the details of the place and times of the next staff testing slots.

5. Preparing for more active travel

As the Bailiwick moves out of this lockdown we know that there will be an expectation that active travel is encouraged as children return to early years settings. The Health Improvement Commission can support early years settings as they consider how best to encourage active travel for all families.

In particular they can:

- Advise on practical arrangements especially for drop-offs and pick-ups
- Promote active travel with your families helping you to send out positive messages
- Advise on routes to and from your setting
- Signpost settings to appropriate bodies such as Traffic and Highways services

I am sharing the following information with you in your professional capacity as an Owner/Leader/Manager of a Day Nursery or Preschool or Childminder.

In preparation to moving into Stage 2 we have written the attached Stage 2 guidance and Requirements for our sector in partnership with Public Health. Stage 2 currently sees Education Providers welcome back all their children and you will therefore have the option to reopen your provision or extend the opening if you are open currently. We know that many of you will already be looking ahead and actively planning for whenever settings may reopen. It is possible that details of the timeframe for reopening of settings may be shared by the CCA at today's media briefing at 1300.

In order to ensure we open safely you must:

- 1. Read and understand the Early Years Provider Stage 2 Requirements and Guidance
- 2. Complete and submit a Stage 2 COVID 19 Risk assessment
- 3. Complete and submit a Benefit-Risk Assessment checklist for Stage 2

Stage 2 Requirements & Guidance

The Stage 2 Requirements and Guidance is attached which includes example check lists and risk assessments as well as a Frequently Asked Questions Section in the Appendix.

Please read this documents and if you have any questions please write them in an email to seyt@gov.gg. The team will struggle to respond to any phone calls this morning as we are required to attend a number of meetings. We will collate these questions and answer them all.

1. Clarification 28 day testing for staff & children who have tested positive for COVID-19

We have received further information relating to staff who tested positive during the second wave of Coronavirus in the Bailiwick. Public Health have advised that it is now safe for colleagues who have recovered to be in the workplace (Early Years or Schools). This is because there is no real possibility to contract the virus again so soon. However, please note the following:

- Check that staff do not have anyone else in the home who is still recovering or a positive case
- Ensure that staff remain very vigilant for symptoms
- Ensure that these staff are included in your testing regimes but only from 28 days after their +ve test result

Confirmation has been sought that the same rules for staff will apply to children who have tested positive for coronavirus. Children who have recovered cannot be tested until 28 days after their positive test result. Parents should be able to provide you with the date from when they can be tested. In such cases please pass this onto the SEYT so we can include this when we send their details to the scheduling team with the effective date.

Apologies that we have provided differing information on this specific issue this week, however, as we have all learnt, things change fast in the present situation.

2. Transport support to access testing.

For children who need support to get to testing, there is help available. Please pass on these details to parents who you know cannot get their children to the PE for testing.

3. Staff Testing

Staff are no longer required to complete the Travel Tracker in advance

Transport - Public Health have advised that a colleague may take one person in their car who does not drive to the East Arm, provided that both occupants wear face coverings, that the passenger sits in the rear of the vehicle, that windows are kept open and the vehicle is cleaned after with detergent/water or suitable detergent/disinfectant wipe.

4. Stage 2

The Committee *for* Education, Sport & Culture have published a document with a summary of the planned exit from lockdown (attached). The SEYT will be working on finalising the details of what this will look like for our sector -It will be similar to the previous phases 3 and 4. It will outline the requirements, in detail, for reopening with clear guidelines on processes that must be in place to be able to reopen, which you will be familiar with. We will share this with you as soon as we can so you can begin planning.

5. Mental Health and Well-being contact sheet

There has been some confusion as to how to fill in the form so we have adapted it (attached) and there is a worked example below to help.

Dear Childminder

We have received the following clarification from the CCA:

 Childminders can currently only work with <u>one</u> family in support of children of essential workers or a child considered to be vulnerable, applying exactly the same criteria as the other educational establishments such as nurseries and schools. Those childminders that are currently working under this criteria are also included in the testing programme and are being regularly tested for Covid19 every 7 days. This will not change when we move into stage 1 – currently planned for Monday 22nd February unless otherwise instructed.

This means that as with teachers in schools, practitioners in nurseries, those childminders that are open are able to bubble with another household of their choosing <u>and</u> can continue working with the family they are currently open and working for.

- 2. Childminders, preschools and nurseries will not reopen until stage 2 <u>unless</u> they are supporting child/ren considered vulnerable or the child/ren of essential workers as set out above. If you are reopening you must contact the SEYT to ensure you are meeting criteria and are included in the testing scheduled.
- 3. If a childminder wishes to enter into an arrangement whereby they are childminding the children of another household not falling into the essential workers criteria or a child considered vulnerable at this time, then they can, but they must be aware that this household must then become their bubble. They will not be able to bubble up with another household on top of this. If you make this decision you are effectively trading this against your ability to bubble with another household and will have made your choice to bubble with one of your mindees family at this time.

I hope this make things clearer for you, if you need any further clarification or have any questions, please get in touch with the team and we will endeavour to support you the best we can.

Thank you for you continual commitment and hard work at this time, we appreciate all you are doing for your children, families and staff teams.

You will have heard yesterday at the media briefing Deputy Ferbrache announce the CCA's decision to move in to Stage 1 for Alderney today (18^{th} February 2021) and for Guernsey on Monday 22^{nd} February. Details of what that means for our community can be found

1. Stage 1 – What This Means For The EYs Sector

There are currently no operational changes to the sector in stage 1.

Childminders

We are waiting for clarification from the Civil Contingency Authority around their announcement regarding bubbles as there has been some discrepancy in information shared. Please be patient and we will send through this clarification as soon as we receive it.

Essential Workers

The essential worker criteria remains unchanged and is as follows:

In order for children to be able to attend your early years setting, both parents must be essential workers or in the case of a single parent, the sole carer is an essential worker. It is also important to note that a place should only be offered to essential workers who need to go out to work away from their home. Parents must complete the following google form if they are applying for a place at your setting. Providers and parents will be notified is their application has been successful.

Children Considered Vulnerable

Please continue to check in with your children and if you have any concerns please indicate this on your weekly MH&WB check form for all children. If you feel a family needs to access a place please contact the team straight away and we will work with you and partner services to support this.

2. Assisted Funding

If a child, who is currently in receipt of assisted funding, are attending your setting, you can invoice the SEYT for their agreed hours. If a child who is in recepipt of assisted funding is not attending your setting during lockdown then assisted funding will not be paid. If your invoice has already been processed then we will work with you to offset this in the summer term payments.

3. Staff & Children Who Have Tested Positive for Covid 19

Public Health have stated that if a child or member of staff has tested positive they are not allowed to return to work/ your setting until 28 days after their positive test as long as Public Health have indicated they have recovered and have obviously retested negative. This may affect some staff being able to return to rotas. Please ensure you indicate the date of the positive test when you submit a child's name for testing to attend your setting as this must be passed onto the testing scheduling team for their records.

4. Proof of a Negative Test

Some parents have had their child's covid test results shared with them by telephone and others have received a text or email. This has caused some problems for some parents and providers in seeing proof of





a negative test. It has therefore been agreed that you no longer have to see proof of a negative test and can trust the parents to be honest with this information. If you would prefer to put something in place to record this with your parents, you could create a simple proforma for parents to sign to confirm their child's negative test.

5. How to avoid becoming a contact of a +ve case

The contact tracing team have captured a common pitfalls document to help staff in the workplace avoid becoming a contact of a positive case. Please ensure that you share this with the staff working in your setting currently.

We are immensely proud of your ongoing commitment and compassion and are very grateful to you all.

Small Business Grant

In the media briefing this afternoon, Paul Whitfield announced that the small Business Grant would be available for those business who employ less than 25 people including those who are self-employed from Monday 15th February. If you do not qualify for this please ensure you apply for the payroll funding scheme, this is open to childminders too.

Face Coverings

Please find attached information around face coverings from PH. It will be law from Saturday 13th February to ensure you are wearing a face covering in an indoor public place including transport. With regards to your own provision we would suggest you to enforce a policy for parents and practitioners to wear face coverings for drop offs and collections and in any communal places such as staff rooms, kitchens, offices etc. where there is more than one person in the space. Children under 11 years old are exempt and for our children we would not expect them or the practitioner to be wearing a mask whilst working. Some providers are using clear face shields so children can clearly see an adults face for communication purposes and nonverbal cues and comfort for snacks and lunch time where they are handling/ serving food or changing nappies and helping with personal hygiene. All your provision has significant mitigations in place such as enhanced cleaning, hand washing, 2 metre social distancing with adults where possible and limited uses of some resources, not forgetting regular Covid tests! All these mitigations will support you in ensuring you are keeping any risk to a minimum. See the diagram below to illustrate how all these mitigations work together to reduce the risks and keep us safe. (Taken from Saskatchewan Health Authority 2020)

Please ensure you telephone any child in your provision you consider to be vulnerable, and collate the following information over the phone:

- 2. Contact number for testing team
- 3. Names/DOB of children
- 4. Consent to share information with HSC testing team
- 5. Consent to receive test result notification by text
- The States Early Years Team will pass on details of the children who will be attending your setting to the scheduling team so they can be tested at the PEH. Testing for children will be clinician led. You will need to check that each child has had a negative result by asking parents and carers to share a screenshot of the text confirming the result.
- Testing for staff will take place at the East Arm. Staff are required to register on the Travel Tracker to do this. Please see letter attached <u>'Staff Testing Letter'</u> with details to pass onto your members of staff.
- You are required to submit attendance data of the number of children and number of staff in your setting to seyt@gov.gg by 0930 daily

Providers Remaining CLOSED

If you are remaining closed you are not required to action anything at the moment, unless any of your families require support to find alternative arrangements. Please ensure if they are essential workers they complete the google form and if they are considered vulnerable contact the SEYT so we can work in partnership with you to support these children.

Health Improvement Commission

HIC knows that schools, Early Years Providers, and the teachers/practitioners/childminders in particular, are often the eyes and ears of the community when it comes to identifying those in need. Therefore, they are keen to work with you to support families. HIC outline below the three ways that they can work with you. They also outline how to identify if a child or family is in need of support and refer to safeguarding procedures.

1. Share our Eat Well @ Home page

3. Food provision

Over the next few weeks there may be an increase in demand from children for food and/or meals. You are best placed to know how to support your children. The Eat Well team at the Health Improvement Commission can provide support to you by:

- Sourcing food for children that you identify as needing support. HIC can work with the charities above and local supermarkets have offered their support with this.
- Providing advice and ideas about how to work with children and families for whom food may be a concern in the coming weeks.

HIC understand that circumstances are constantly changing and that each provider will have different requirements and arrangements but are there to help with an area that many of you have recently flagged as needing attention. Guidance from Public Health has been given to us regarding staffing of Early Years settings that are planning on opening next week:

• Try to keep movement of staff to a minimum





- Try to keep individuals in one room or working with one age range only in order to limit possible contamination if a case was to be confirmed in your setting
- Lunchtime cover could be avoided by timetabling staff to mornings or afternoons
- No office staff are to be on site during the lockdown period, only practitioners working directly with children and babies, this does not include managers who are facilitating and supporting the delivery
- Ensure you have enough qualified, tested staff to step in should anyone become ill
- Ensure you have a qualified first aider on site and on shift

Funding & Charges

Charging – Please ensure parents are aware of what they are required to pay at this time. The SEYT are receiving a number of emails asking about charges whilst you are closed. These are private contracts between you and your families, please ensure you are clear with your requests and we would advise ensuring open communication to discuss these delicate and sensitive issues at this time. SEYT are advising parents to go back to their provider to discuss their concerns and questions.

PSEF – As with the previous lockdown last year, if a child is attending from another setting who has PSEF, their hours can be claimed back from their usual provider for hours during term time – this does not apply to half term. Please invoice their usual provider indicating dates and hours to be claimed.

Assisted Funding: Please contact the SEYT if any of your children or children from another setting are attending and receive Assisted Funding we will support these payments bespokely.

I hope you, your families and teams are remaining safe and well during these challenging times. Our emails are down so I am communicating through my google account currently.

You will no doubt be aware that planning is underway to ensure the safe reopening of schools and early years settings. It has been agreed that Early Years settings can open from half-term for the children of essential workers and vulnerable children. Given the unsettled times the focus needs to be on minimising the risk of the virus spreading and so numbers of children in settings and at school need to be as limited as possible. It has therefore been agreed that in order for children to be able to attend school or an early years setting, both parents must be essential workers or in the case of a single parent, the sole carer is an essential worker. It is also important to note that a place should only be offered to essential workers who need to go out to work.

We appreciate that it can be difficult communicating this message to parents and carers so to ensure consistency, we would be grateful if you could ask parents to complete an application for a place at your setting. A suggested draft email (attached) is provided as an attachment to this email. All applications will be assessed centrally and decisions will be communicated directly to parents from the States Early Years Team. Parents must complete the following google form if they are applying for a place at your setting.

Arrangements for vulnerable children should be managed at a setting level as you will be best placed to understand which children should be offered a place. We would be grateful if you could communicate to those families and confirm those names with the States Early Years team.

Please ensure you telephone any child in your provision you consider to be vulnerable, and collate the following information over the phone:

Answers are required to all 5 questions which will need to be passed on to the SEYT for collation and onward sending to the scheduling team

- 1. Name of parents
- 2. Contact number for testing team
- 3. Names/DOB of children
- 4. Consent to share information with HSC testing team
- 5. Consent to receive test result notification by text

ACTION – Contact all your families whose children you consider to be vulnerable and collate the information as requested and send to SEYT as soon as possible

Testing

In order for all education settings to reopen safely, all staff and children will need to undergo testing in advance and be in receipt of a negative COVID-19 test result. Working with our colleagues in Public Health, it is requested that any





staff who will be at your setting during half-term or the week after are tested this week. Staff will need to agree to be part of a repeat 7 day testing programme.

ACTION - Collate the names of all staff who will be working and send information to SEYT as soon as possible. The SEYT will coordinate with PH and the testing team all testing schedules.

Testing for staff will take place at the East Arm. You will need to register on the Travel Tracker to do this. Please see instructions below on how to do this. We know you haven't travelled anywhere but the team carrying out the testing is the same team who normally do this at the airport/port so we are using the same system to keep things simple. The test for staff will be a self-swab test rather than a clinician led test which you may have heard about or experienced at the Princess Elizabeth Hospital.

SEYT will pass on details of your staff's name, which will be passed on to the East Arm team for registration purposes when you arrive for your test. Staff who are supporting children during half-term will be tested first (approx. Friday or Saturday), with back up teams being tested late Saturday or Sunday. Staff must inform the setting leader of a positive test result at the earliest opportunity or if they have not been given a testing slot. If your staff have not been given a testing slot by Friday, please let the States Early Years Team know.

The States Early Years Team will pass on details of the children who will be attending your setting to the scheduling team so they can be tested at the PEH. Testing for children will be clinician led. You will need to check that each child has had a negative result by asking parents and carers to share a screenshot of the text confirming the result. We hope this email answers your questions about the arrangements for reopening next week, but please do get in touch with any questions you have. We are keen to make sure that you are as supported as possible during this difficult time.

Dear Preschool/Day Nursery/Childminder

In our attempt to support the response to this second wave of Covid19 in partnership with Public Health, we recently requested information from you if you are planning on remaining open.

As you are an Independent Data Controller in your own right, it's your responsibility to hold information about all the children which attend your setting and information regarding the parents of those children. As the States Early Years Team, we hold data for children accessing Preschool Funding, Assisted Funding and data from HSC of Children in Need, children on a Child Protection order and Looked After Children. We have been advised that as independent data controllers, Public Health will not use the central data we have collated, but if they require any data that you hold, they will contact individuals in your provision through you as the data controller and they will do that on an individual basis. **The SEYT therefore no longer require this information and will be deleting this with immediate effect.**

Given the developing situation, it is important to be prepared that Public Health may contact you at any time and may require accurate up to date information on:

- Staff names and contact numbers (for Preschools/Day Nurseries)
- Children's names and their parent's contact numbers
- Whether any parents/guardians of those children are considered to be key workers
- Names of children attending which may be considered to be vulnerable

Fortunately, you have just done this in providing this information to us, so please keep this safe and up to date!

Any further communications, updates and any changes from CCA and SoG Central Communications Teams will be shared as usual from our team.

We will be in touch later this week with further information with regards to meeting our duty of care around safeguarding all our children whether they are in attendance or not. If you do have any safeguarding concerns as you have been in contact with your children and families this week you must follow the safeguarding process and report these in the normal way.

Business Support & The Co Funding Scheme

From 23rd January 2021 applicable businesses that are experiencing a significant downturn as a result of the circuit-breaker lockdown will be able to apply through the Payroll Co-Funding Scheme for a reimbursement of 80% of the minimum wage for their employees, capped at 42 hours per week. Employers must make up the remaining 20% to ensure that employees are paid at least the minimum wage (£8.70 an hour) for the hours they would normally work.

The Payroll Co-funding scheme will be paid monthly in arrears. From February 1st, applications can be made for reimbursement payments for the period 23rd January, 2021 to 31st January, 2021. The payment for this period will be capped at 42 hours per person. February payroll reimbursement applications will open on 1st March, 2021.

At the media briefing today the Civil Contingency Authority (CCA) and Public Health have made the decision to extend the fire break, which means ALL education provision will remain closed to ALL children on Wednesday, Thursday and Friday of this week. This will be reviewed over the weekend (30/31 January 2021).

Further details explaining this decision have been shared during the briefing by Dr Brink and members of the CCA.

Please find attached a copy of the press release with details of the decision today to keep all educational settings closed.

Schools, colleges and early years providers (pre-schools, nurseries and child-minders) will remain closed to ALL students for the rest of this week.

The decision to close education sites to all students – including vulnerable students and children of essential workers – for the rest of this week will help support our principle objective to stop the rapid transmission of COVID-19.

Cases have continued to be identified in education settings but **parents are again asked to NOT contact Public Health**.

The scheduling team will contact relevant student groups and staff at schools where cases have been confirmed to book them in for tests, **if these are required. Please do not contact Public Health to instigate testing yourselves.** However, if you or your children develop symptoms please contact the clinical helpline 756938/756969 or your GP. For more information about symptoms please visit https://covid19.gov.gg/quidance/symptoms.

While it is very difficult to be able to state with any kind of certainty what next week will bring, we are examining all options to try and get sites open as quickly as possible, and in the safest way possible, to support vulnerable students and the children of essential workers. A further update will be provided later this week and we thank all education staff for adapting to rapidly-changing circumstances.

All sites where cases have been confirmed are being deep cleaned.

Schools and the College will continue rolling the soft start to Distance Learning. Schools will be in touch with parents to provide relevant materials although it is important to note that this Distance Learning will not seek to replicate a normal school day.

Dr Nicola Brink, Director of Public Health, said:

'We have continued to identify cases in education settings and it remains cause for concern. Keeping education sites closed to all students is an important measures as we remain focused on our principle objective of trying to stop the rapid transmission of COVID-19. We are acutely aware of the impact for vulnerable students currently unable to be in school and for those parents who are essential staff and we as a community need to be in work. We are examining all options to get sites open as quickly as possible, and in the safest way possible, to support vulnerable students and the children of essential workers.'

Please share this with your parents and staff **AFTER 1630** once the Media Briefing has begun.

Schools, colleges and early years providers (pre-schools, nurseries and child-minders) will remain closed to ALL students for the rest of this week.

The decision to close education sites to all students – including vulnerable students and children of essential workers – for the rest of this week will help support our principle objective to stop the rapid transmission of COVID-19.

Cases have continued to be identified in education settings but **parents are again asked to NOT contact Public Health**.

The scheduling team will contact relevant student groups and staff at schools where cases have been confirmed to book them in for tests, **if these are required. Please do not contact Public Health to instigate testing yourselves.** However, if you or your children develop symptoms please contact the clinical helpline 756938/756969 or your GP. For more information about symptoms please visit https://covid19.gov.gg/quidance/symptoms.

While it is very difficult to be able to state with any kind of certainty what next week will bring, we are examining all options to try and get sites open as quickly as possible, and in the safest way possible, to support vulnerable students and the children of essential workers. A further update will be provided later this week and we thank all education staff for adapting to rapidly-changing circumstances.

All sites where cases have been confirmed are being deep cleaned.

Schools and the College will continue rolling the soft start to Distance Learning. Schools will be in touch with parents to provide relevant materials although it is important to note that this Distance Learning will not seek to replicate a normal school day.

Dr Nicola Brink, Director of Public Health, said:

'We have continued to identify cases in education settings and it remains cause for concern. Keeping education sites closed to all students is an important measures as we remain focused on our principle objective of trying to stop the rapid transmission of COVID-19. We are acutely aware of the impact for vulnerable students currently unable to be in school and for those parents who are essential staff and we as a community need to be in work. We are examining all options to get sites open as quickly as possible, and in the safest way possible, to support vulnerable students and the children of essential workers.'

Parents received advice from their child's school this morning to reassure them following confirmation of COVID-19 cases across seven education settings.

Dear Provider

We have received confirmation from Public Health that all Provision <u>must</u> be deep cleaned before opening to their children who are considered vulnerable or of essential workers once the Fire Break has been lifted.

A deep clean requires the following:

All settings should undertake a thorough decontamination of all surfaces (desks, tables, chairs, light switches, handles, touchpoints etc.) with Chlor-Clean (which meets the 1000ppm chlorine requirement from Public Health) or Oxivir Plus, which isn't chlorine-based but whose use has been approved by Public Health.

Chlor-Clean is kept in stock by local suppliers such as Mercury or A1 and I know that A1 have a stock of 750ml ready-to-use Oxivir Plus spray bottles – available via Michael.Niedzialek@foxtrading.co.uk or Anthony.Hobson@foxtrading.co.uk.

All soft furnishing should be removed where possible and if required (i.e. sleeping materials) they should be washed in 60°C plus.

Staff who are cleaning a known contaminated area should wear personal protective equipment (PPE), although since the extent of contamination is unclear we've suggested to our staff that they should wear this for all areas. The PPE includes: water-resistant masks, disposable aprons and disposable gloves. All used PPE items should be double-bagged, just in case they are contaminated. Staff have also been asked to practise social distancing at all times.

Dear Early Years Provider

As you will have heard from the Press Briefing the decision to move into a lockdown has be made in order to reduce risk of community seeding and ensure we are kept safe. This means the following for our sector and will be in place immediately (12 noon 23/1/21 until further notice, reviewed in 14 days or sooner as necessary) where we will continue to follow government guidance.

Lockdown Information for Preschools, Day Nurseries & Childminders

Essential Workers

During the lockdown children of essential workers and those children who are considered vulnerable will be able to attend their schools, colleges and Early Years Providers (pre-schools, nurseries and childminders)

All children of parents not defined as essential workers will be required to stay at home. And parents should not rely for childcare upon those who are advised to be in the stringent social distancing category, such grandparents, friends or family members with underlying conditions. Parents should also ensure that children observe the same social distancing principles as adults.

For children to continue to attend school, college or early years during this period it is important to note that BOTH parents (unless single parent household) MUST be essential workers. The only exception is where one parent is a nurse, doctor, other key health or care worker, teaching staff, Early Years Practitioner (this includes childminders) or staff essential to supporting the States of Guernsey's response to COVID-19, whose child(ren) will be able to attend school, college or early years even if the other parent does not fall into the essential worker category. In this instance a parent should only use your provision if they are working. If their place of work is closed and they are not required to attend their workplace to provide an emergency service i.e. on call health care professionals, they should not send their child/ren to your provision and remain at home. This will help all our educational settings keep the numbers of children as low as possible in the days ahead.

Childminders may continue to operate with **ONE family** of essential worker children only. If a childminder has more than one essential worker family they **cannot mix them**.

If you work in more than one EY setting/school/health centre/hospital/care home you can only work in one place of work during lockdown you are not able to work across more than one of these places of work. If you are unsure please get in contact with the SEYT for guidance.

Which types of workers are classed as essential?

The document attached (Essential Worker Guidance) has a **list** of what roles are considered **essential** workers in this instance.

Preschool Education Funding

Preschool Funding will continue to be allocated to all settings for all children regardless of numbers and whether they are able to run or not. If you are closed and one of your children is entitled to a place during lockdown please contact the SEYT to discuss allocating funding to their temporary setting.

Children with an SEND





Children with special educational needs will also be able to attend EY settings, childminders and schools, this includes Le Rondin, Le Murier, Les Voies and additional needs bases, if parents wish to send them. Guernsey College of Further Education will be working with parents of students with special educational needs to ensure that they are supported. These measures will be in place until further notice.

Safeguarding and Vulnerable Children

All children classed as vulnerable (looked after children, on child protection plans and/or a care requirement, children in need, children accessing Assisted Funding to attend a setting) can attend their EY setting or childminder provision. There may be children you know about who are not attending as usual, either a setting or childminder, please continue to be in regular contact with parents/carers to check how they are. If you need any support or guidance please contact the SEYT.

In the March 2020 lockdown some parents/carers may have decided to keep a vulnerable child/children at home, but may have changed their minds or their needs may have changed about accessing your provision. Parents/carers may not be able to communicate this or know how to do this, so a prompt from you could assist and support them and their child/ren. Please record provision for all vulnerable children and share this information with the States Early Years Team on the form attached and below under 'Remaining Open & Setting Closures'.

MASH continue to meet virtually and can be contacted on 723182 for referrals or if you need to discuss any safeguarding or support issues. The police should be contacted on 725111, if it is an emergency or 999. Please also refer to the ISCP website for information http://iscp.qq/. If you need to discuss any safeguarding children matters or discuss a vulnerable child please call Linda Roberts on 07839 249995.

Remaining Open & Setting Closures

If you are remaining open please complete the first part of the form below (also attached as a word document) and return it to the SEYT as soon as possible.

If you feel you cannot operate and need to temporarily close you must complete the ALL of the form below (also attached as a word document) and return to the SEYT as soon as possible. Please pass on the SEYT contact details to parents/carers of essential worker children and those considered vulnerable only so we can support them to access an alternative provider for the duration of the lockdown.

A high temperature is 37.8° or above. Contact the child's parents and advise them to come and collect the child. If the temperature persists parents should contact the Clinical Helpline on: **01481 756938 or 01481 756969.** You may feel there is an explanation for the high temperature e.g. recent vaccinations, teething etc. you cannot be certain this is the only reason, therefore **DO NOT** make these assumptions and follow the guidance.

How do we clean our carpets and sofas as they cannot be removed?

Daily vacuuming with suitable attachments and spot cleaning must be in place. Anti-Bacteria sprays for fabrics and steam cleaners can be used, if available, in addition to vacuuming and spot cleaning. Most fabrics can be sponged/damp wiped if they are washable, leather or faux leather can be safely wiped with soapy water. If this is not possible, the best alternative would be to have washable loose covers or throw. These should be frequently washed and replaced by clean ones. There should be a focus on decontamination following body fluid spills, such as blood, vomit, urine etc. Spot cleaning should be done with an appropriate carpet cleaning product and not just water. Where there has been visible contamination with body fluids of difficult to clean items such as soft furnishings, cushions and mattresses, they should be disposed of. If you use a steam cleaner it must be properly cleaned out after use. Washable items should be laundered on as hot a cycle as possible and then tumble dried. These should be kept separately in bags in the laundry room / area until they are washed.

- Could a Provider arrange an evening visit with a new child and parent or prospective parent?

 Yes this can take place for up to an hour, no other children can be present and preferably one member of staff.

 Adults must maintain physical distancing and full enhanced cleaning would take place afterwards of the areas used. No one else in should be using the building?
- Can children take home artwork/ craftwork/ models that they have made at their provision? Yes, the risk of transmission on paper is quite low and it is likely it will only be their child touching it. However to be really safe it could be kept in a plastic wallet, which could be wipeable and sent home after 72 hours. There are lots of activities and resources you could provide, the following are just some examples of activities and resources you could consider offering:

Water play

No troughs and shared water play, however consider water painting with individual buckets and brushes. Washing cars and trikes, babies anything that won't be destroyed with soap and water. Use individual sponges and cloths.

Building Dens

Ensure any fabric is washed after you have used it (hot wash 60° or above and tumbled dried if possible) or wiped clean with soap and water and detergent if they are plastic.

Small World

Small world is essential for children to have an opportunity to express themselves, plastic small world can be cleaned easier – top tip; put larger quantities in a net bag dunk and wash in hot soapy water then dunk and leave in Milton (check the instructions for recommended length of time to be left to soak) and air dry for the next day. Wooden, stone, natural loose part accessories can be used in a rota if they can be washed and cleaned and if they cannot be cleaned effectively left for 72 hours before being used again.

Home Corner

It may be stripped back but an opportunity to act out and express themselves through role play is essential. Perhaps you could consider cleaning stuff in the role play – Not detergents but soapy water sprays! **Keep all cleaning products away from children!** The opportunities to talk and discuss why we are cleaning more would





be natural in this play. But also familiar home corners are comforting and real for children. For most children this is the most familiar experience over lockdown and they can share this with you by talking about it and recreating it.

Construction

A great expressive creative resource, same cleaning applies as with small world. Large wooden blocks can be wiped down and left for 72 hours before being used again.

Lego, Mobilo, connex etc. can be used again once effectively cleaned.

Craft and Painting

Another essential activity for enabling expression. Paint brushes, sponges, rollers, stampers etc. can be cleaned after use by individuals. (consider a box to put used tools in so they can be cleaned and replaced). Craft material can be provided but you will need to provide this for an individual rather than shared resources (consider small trays/ box/ tubs that you can put a selection of craft material in for a child to use, any craft not used can be put away for 72 hours before it can be added back for use). PH have advised craft work and painting etc. can be stored in a plastic envelope where possible and left for 72 hours before being allowed home.

Jigsaws & Board Games

They can be cleaned as far as possible or put away for 72 hours before being used again.

Sensory play

This can be done with individual trays or tubs and disposed of once the activity has finished.

The best resource of all – YOU!

Ensure you are clean and washed regularly! © Talking, being, loving, caring, suggesting, guiding, reminding, reassuring, smiling, laughing, joking, listening and responding is all you do naturally for your children. This will be the biggest resource for your children. Meet them where they are, listen and understand their experiences and respond to meet their needs! This is what you do best so don't go changing now!

As you will have heard in the media briefing this afternoon, Dr Nikki Brink discussed the necessary measures of ensuring you keep a comprehensive daily contract tracing register, should there be a confirmed case of Covid-19. The contract tracing team would commence Track and Trace 1 hour after a positive test result is received 24 hours a day if required.

Whilst we currently have your contact details on our webpage I need to you provide a current contact number in any 24 hour period. that can be shared with the Contract Tracing Team. This may be different to the one you have provided previously which is on our webpage (www.gov.gg/seyt). By providing this, you are consenting for the States Early Years Team to share this with the Contract Tracing Team with the purpose of using it if there is a positive case and they need to begin their process of Track and Trace.

Dear Childminders

Thank you for your continued patience and professionalism that you have shown this week amid some confusion and subsequent frustration. Many of you have communicated with us and this has been appreciated and helpful.

As you will have heard in the briefing today happily for everyone who lives on the islands, the pace of recovery from Covid-19 across the Bailiwick is so remarkably positive Public Health have now announced a transition to Phase 4 of the Bailiwick's exit strategy. This is a significant step forward as it will mean that most businesses and organisations that had not been able to function fully previously will be able to return to work. For us, this also means that the Director of Public Health has legally stated that she can no longer justify the closure or the partial closure of our preschools, day nurseries and childminders. You will have heard about the science behind this decision today, but suffice to say that the situation is so positive that it places Guernsey and the islands amongst the lowest risk jurisdictions in the world.

This latest public health advice now allows Childminders, from the 1st June 2020, to welcome **all their families** back and reopen if they have been closed or extend their offer to include their other families if they have remained open for essential worker or our vulnerable children. © This will be shared in the media release which accompanies the Media briefing and will be published on the website; www.gov.gg

In order to reopen or extend your offer if you have remained open, you <u>must</u> submit to the SEYT (<u>SEYT@gov.gg</u>) a <u>risk assessment</u> and the <u>recovery checklist</u> which you have been issued earlier this week. There is a blank risk assessment and recovery checklist attached. I have also attached a revised guidance for you which outlines Public Health's expectations for operating at Phase 4. Please contact the team for support to complete this and you <u>must</u> ensure an Officer has signed off your risk assessment and checklist <u>before</u> opening, otherwise you will be in breach of Public Health's requirements. The enhanced hygiene and cleaning procedures ensure effective mitigations are in place to keep the children, families and staff safe and well and that we are meeting the requirements set out by Public Health within which we are permitted to operate.

Dear childminder

Once again thank you for your patience and professionalism. We are understandably receiving high numbers of emails and calls regarding clarification of information for phase 3 recovery and what that means for our childminders. This has been further confused by inaccurate information in our local media, which we are working to rectify with our Comms team.

We are currently waiting to hear from the Committee *for* Health & Social Care and Public Health with regards to a revised statement for childminders. This means the following restrictions <u>remains</u> in place now:

- You are only allowed to childmind for <u>one family</u> who are essential workers or whose family may be vulnerable
- You are <u>not</u> allowed to mind a different family on different days e.g. child A on Monday, Child B on a Tuesday.
- You can mind one family as well as your own children.
- You can mind more than one family only if they are part of your extended household bubble. You cannot mind an additional child in this instance.

Public Health have agreed separate guidance for our preschools and day nurseries, as they are not working in family homes and are in business premises that are closed at the end of each day. They are monitoring the local epidemiological data to support their advice and will use this to further relax the current restrictions as soon as it is safe to do so. Public Health are making these decisions to ensure the safety of yourselves and your families and those that you mind, whilst also ensuring we protect the positive gains of our overall response as a community. It is appreciated that for some they may be moving too slowly and for others they are moving too fast, however protecting our community is essential in our recovery.

<u>Preschools and day nurseries</u> are currently working with our team to plan to be able to offer places, prioritising preschool children, in bubbles of 8, following comprehensive guidance for operation.

We were planning on sending you a comprehensive pack of information to support you in planning the next phase, however the information that was shared on Friday had remained the same as Phase 1 & 2 for childminders, so effectively it currently means no further changes.

I will share with you, as soon as I can, the revised guidance from HSC and PH. In the meantime, we have attached the following documents should you wish to begin planning for when further relaxation of the restrictions are announced:

- Recovery Guidance comprehensively sets out operational procedure. This will align your processes and assist in your planning for moving into Phase 3 and beyond.
- Recovery checklist covers key areas to check are in place and have been planned and considered.
- Suggested Cleaning Schedule a useful schedule which could be used daily. You may have your
 own version which you can adapt to include the necessary enhancements at this time.
- The Enhanced Environmental cleaning guidance for EY Providers
- Guidance for visits during Covid19 recovery this explains the process should we have to visit you for regulatory purposes.

You must update your own risk assessment documents to reflect the current enhanced requirements and the guidance should support you to do this. We are asking, under Public Health's advice, that if you are currently open, you submit a completed Recovery Checklist (attached) with your risk assessment and you will be required to do the same if you are currently closed when Public Health's guidance allows you to reopen. The SEYT will support you to do this, building on the strong procedures you already have in place.

Your designated Officer will be in contact over the next few days and will be available to work with you and support you in your planning and preparation. Remember there is no such thing as a daft question! We are working in unprecedented times so we are here to work with you to find safe solutions.

Officers will only arrange a site visit (without the presence of children) when all the elements above are in place and have been evaluated and agreed but the States Early Years Team.

We hope you are continuing to stay well and safe. Myself and the team are grateful for your actions to this pandemic and for your continual communication.

We would like to update you with a number of issues that have developed for information and clarification.

- At the media conference this afternoon you would have heard about some changes to our lockdown effective from Saturday 25/4/2020.
 The core message remains to stay at home if you can as we have been very successful in flattening the curve. However, some businesses can now potentially reopen. Information about which businesses can do so, and the public health requirements they must be able to meet, can be found here: https://covid19.gov.gg/guidance/business/lockdownupdate
- Some leaders have highlighted that they are receiving requests for places for children from families not classed as key-workers or vulnerable as those families explore how they might return to work in some form. This is an expected consequence of the change to working patterns in some sectors as a result of the Bailiwick's move into the next phase of our Covid-19 response. Following consultation with partners in Public Health, we can confirm that our education settings (Schools, preschools, day nurseries and childminders) are not able to provide childcare for families who do not meet the essential worker criteria (as outlined in the guidance in the portal or via the States of Guernsey site) and/or are not considered to be vulnerable. This criteria has not changed and remains in place and can be found here: https://covid19.gov.gg/guidance/business/critical

If you receive enquiries about this, please direct families to the advice that Public Health has shared and which outlines the definition of essential workers. The States of Guernsey Comms Team is aware of this and may reinforce this message, as needed, more broadly in due course. If you need any further support please contact our team and we will support you to deal with this considerately and effectively.

- Bright Beginnings Children Centre and Les Cotils are working together to provide free hot meals for families who are vulnerable supplementing the fantastic work Guernsey Welfare have been providing. If you have any families that you feel would benefit from this, please let us know and talk to them about accessing this service or contact Rachel Copeland directly on rachelcopeland54@gmail.com
- A decision to allow Pre School Education Funding to follow a child during this time, if they are children of essential workers or from our vulnerable families, their usual provider is currently closed and they are attending an alternative provider, has been agreed. I have discussed this with the small number of effected providers who are closed at this time and they have all been very supportive and are in agreement with the decision.
 Given that we do not know how long we will be working within these restrictions, we have requested that managers arrange to invoice the child's previous provider for the funded hours this term. That way we can be assured of flexibility when we return to 'Business As Usual' rather than make adjustments in the 20% payment. If you would like any further information please give me a call and I will be happy to answer any questions and talk through the process.
- We are also looking to send out a reminder to all parents and carers in the Bailiwick, so they can register for their child's 15 hours Preschool Education Funding for September 2020 now. Please be reminded that you can share with parents the information on our webpage including the FAQs https://gov.gg/CHttpHandler.ashx?id=118259&p=0 and the Parental Declaration Form with Guidance https://gov.gg/CHttpHandler.ashx?id=102814&p=0





Completed Parental Declaration Forms for this September 2020 can either be emailed or posted to us at Le Rondin. Children's ID will still need to be checked as per the Declaration form, however, during our current circumstances and to adhere to the physical distancing mandate, parents can provide either their child's passport or their birth certificate as a scanned document or as a photograph of the ID to you. Preschool/Nursery will record the unique number on the signed Parental Declaration Form and then will delete the photo or scanned document and will not keep a record of this.

In light of today's media conference I would like to update you with the following to support you at this time:

Schools are to remain closed for the next half term (up until 31/05/20 end of half term). During this time SEND Schools will offer access to all who request it (subject to capacity) and all other schools will be open to the following children and young people:

• Those of key workers (https://covid19.gov.gg/guidance/business/critical Under the Heading 'Which types of workers are classed as essential?')

Plus 'vulnerable children'; who:

- Have a determination of SEND
- Are on the CP register
- Recognised as CIN (Child in Need)
- Subject to Care Requirement
- LAC; in foster care or in Residential Care
- Any other child the school recognises as being vulnerable

However, the decision will be kept under review and education providers could open earlier if supported by evidence. We will keep you informed as and when these decisions are made and the potential impact on our sector.

This means that the directive for our sector as Early Years Providers remains the same. Please ensure you are following the guidance on supporting your most vulnerable families this is essential whether you are open or not at this time.

<u>Safeguarding and Vulnerable Children (looked after children, on child protection plans and/or a care requirement, children in need, children accessing additional funding to attend a setting.)</u>

You are all reminded to please continue to be in contact with the parents/carers of the vulnerable children you would normally be working with and who are not attending your provision as usual, to check how they are. Lots of you are messaging parents/carers with ideas, activities, photos and staying in touch, which is much appreciated. If you haven't already set this up please do consider doing this as it allows families to stay connected with you, assists families to have new initiatives to try and will support children when they return to their typical routine. (please see links below for suggested ideas).

Initially some parents/carers of our vulnerable children may have decided to keep their child/children at home, but may have changed their minds about wanting a regular routine. These parents/carers may not be able to communicate this or know how to do this, so a prompt from you could assist. For the week beginning 20th April 2020, please make contact with the parents/carers of all vulnerable children who would normally attend your provision for an update and then share this information with the States Early Years Team.

MASH continue to meet daily virtually and can be contacted on 723182 for referrals or if you need to discuss any safeguarding or support issues. The police should be contacted on 725111, if it is an emergency.

I wanted to update you with the announcement today from Deputy St. Pier that we will be continuing in lockdown at least until 2359 on the 18th April 2020. We are expecting further information to be agreed and released later next week with regards to the plans for our schools after the Easter holidays. Effectively this means that at the moment we continue to operate under the same restrictions until further notice.

The additional exceptions to the lockdown mandate are around allowing additional deliveries to individual homes, however there are specific requirements that need to be met for this to be allowed. Please see the information and rationale around this here: https://covid19.gov.gg/guidance/business

Please find attached an essential worker travel document for use by you and your teams as essential workers when travelling to/from their place of work or elsewhere on the island in the course of business. This will provide some confirmation for essential workers if stopped and asked by the Police their reason for travel. Please could you arrange for this to be administered within your teams as appropriate. You can add the name of your setting at the top, or for childminders if you don't have a business name just write 'Childminder', then complete the bottom section for individuals. For our childminders I would also recommend carrying your ID cards and if other providers have ID please use them. The following has been issued by HSC as guidance:

Essential Worker Travel

In order to protect our Bailiwick Community and encourage people to 'stay at home', our colleagues in Law enforcement are occasionally stopping cars to ask people's reason for travel. We recognise that many, if not most of you need to travel to and from your place of work and/or elsewhere on the Island in the course of your business and service delivery.

As per standard practices, we ask that you have your work ID badge on you at all times. Your ID Badge is sufficient to identify you as a Key Worker, however should you feel more comfortable, please feel free to print & display the notice attached in addition.

Kindly note these are for your use only, not for family members / friends / anyone else. If you or your teams have any problems please feel free to signpost them to our team (SEYT). Following further additional advice, the attached document 'SoG Confirmation of Essential Workers' has been slightly revised, and has some Frequently Asked Questions.

We have had a number of enquiries regarding collecting Parental Declaration Forms for September 2020. We will be happy to receive them if you can post them C/O The States Early Years Team to Le Rondin School and Centre or securely email them to seyt@gov.gg either as an electronic document or scanned copy. With regards to checking the ID of a child, you still need proof of either the child's passport or birth certificate. However during our current circumstances and to adhere to the physical distancing mandate, this can be provided to you either as a scanned document or as a photograph of the ID. Please record the unique number on the Parental Declaration Form and then delete the photo or scanned document, you must not keep a record of this. We will be advised if later checks of original documents will be required in the Autumn term.

 We will continue to provide updates as we are able to; however things are moving at a fast pace, so you may actually hear some information via public briefings before we have a chance to share them with you.

It is important to highlight that, whilst significant changes to life on the islands are now necessary, the plans that you have already put in place in your settings at this time and for the next few weeks should remain the same. This means that, as a critical part of the community's infrastructure, your setting should remain open with the staffing that you have available in order to provide care and support for those children who need to attend.

The announcement made it clear to us all that childcare provision for the children of critical workers will continue during the 14 day period. The public has been told that the children of workers who have been identified as critical will be able to attend their usual setting. The announcement also stated that this arrangement will continue to be provided over the Easter break. This will ensure that our critical services can still be delivered during this period – in particular those involving health and care workers. If you aren't usually open over Easter please contact us and we can discuss ways of supporting you to remain open or ensure we provide cover for those children of key workers during this time.

Please remember that the school/nursery/pre-school/childminder closures are necessary to minimise social contact across the island and to reduce the possibility of the virus spreading as advised and mandated by Public Health.

Just to be clear - Both parents must be key workers in order to send their child to school, preschool, nursery or a childminder. This is unless <u>one</u> parent is a **doctor**, **nurse**, **key health worker**, **key care worker**, **teacher**, **LSA**, **preschools/nursery practitioner or a childminder** if this is the case then their child(ren) can attend even if the other parent is not a key worker.

We know this is very difficult to manage, but this is essential to reduce any unnecessary social contact. The decision is a public health decision to protect all islanders and to minimise the risk of high numbers.

The States Early Years Team are asking parents to make sensible judgement calls on whether they fall into the essential worker category and to check with their employer to see if their attendance at work is essential.

Further to our email yesterday evening, we would like to share the following updates with you:

The most recent scientific advice on how to further limit the spread of COVID-19 is clear. If children can stay safely at home, they should, to limit the chance of the virus spreading. That is why the States of Guernsey has asked parents to keep their children at home, wherever possible, and asked schools, our preschools, day nurseries and childminders to remain open only for those children who absolutely need to attend.

It is important to underline that schools, preschools, day nurseries and childminders remain safe places for children. But the fewer children making the journey to school and early years providers, the lower the risk that the virus can spread and infect vulnerable individuals in wider society.

- 1. If it is at all possible for children to be at home, then they should be.
- 2. If a child needs specialist support, is vulnerable or has <u>both</u> parents who are critical workers, other than for children where one parent is a nurse, doctor or other key health or care worker and the other parent/carer doesn't fall into a key worker category, their child(ren) will be able to attend school, preschool, day nursery or childminder then provision will be available for them.

Parents should not rely for childcare upon those who are advised to be in the stringent social distancing category such as grandparents, friends, or family members with underlying conditions.

The guidance for schools, day nurseries, preschools and childminders with regards to remaining open for our parents who are key workers is attached.

The guidance clearly states that <u>BOTH</u> parents need to be key workers in order to access your provision, this is unless one parent is a nurse, doctor or other key health or care worker and the other doesn't fall into a key worker category, their child(ren) will be able to attend a provision.

All day nurseries and preschools MUST complete the attached table (example is below) and email back to SEYT@education.gg by 5pm with as much detail as possible. If you are unable to open at this time we will work with you and the families who are key workers to ensure they are able to access EY provision from 23rd March until the time the enforcement is lifted.

EXAMPLE OF COMPLETED FORM

If you make the decision to close, we will work with you to provide an official document so you can show your insurers.

If you are financially affected by these directives please see the attached 'Support for your Business' guide. Please note The Social Security element for the self-employed has just been updated.





Please report any information of people illegally childminding or operating outside of the law during this time to SEYT@education.gg we will report directly to the Civil Contingency Authority. Not complying with the restrictions or requirements imposed under these powers will be an offence.

Parents are reminded that we are operating in unprecedented circumstances and as such we need to accept that our business as usual will change not just for us in our sector but for the whole of society and all other work sectors. It is important and vital to our immediate safety and health that we adhere to the necessary changes required for this temporary time and mandated from Public Health.

It is important for us all to understand that life will be different and we must work together through patience, cooperation and consideration - no matter how hard, we must all work together and do our bit.

As you are all aware, we have been informed this afternoon of the decision to enforce a temporary and partial closure of our schools, colleges and early years providers, which includes all preschools, day nurseries and childminders.

Just to reiterate the message that was announced this afternoon by the Strategic Co-ordinating Group based on advice and evidence from Dr Nikki Brink (Director of Public Health) and her team who are reacting dynamically to these ever changing circumstances.

In order to continue to act and continue to ensure we manage the risks of this infection we will be taking additional social distancing measures. These will be temporary at this stage, enforced from Monday 23rd March and will include temporary and partial closures of schools, colleges and all day nurseries, preschools and childminders. This is enforceable, as the Civil Contingencies Authority has given power to the Director of Public Health to enforce these temporary and partial closures and they will be working with the Bailiwick Enforcement Officers to ensure this is complied with. Not complying with the restrictions or requirements imposed under these powers will be an offence.

Schools, colleges, preschools, day nurseries and childminders will only remain open for children whose parents/guardians are key workers. These measures will provide extra "brakes" to slow down transmission of the virus and prevent our healthcare system from being overwhelmed.

It is important that all day nurseries, preschools and childminders remain open, where possible, for children whose parents are classed as key workers. Confirmation of who will be classed as a key worker will follow tomorrow.

All staff working from Monday 23rd March in our preschools, day nurseries or as a childminder are classed as key workers themselves and therefore if you have children, they will be able to continue to attend school, preschools, day nurseries or a childminder.

If you are opening to support our key workers and you find your ratios and staffing are becoming critical please contact us so we can help support you to remain open. You <u>must</u> let us know if your staffing becomes critical or if you are a childminder yourself, become unwell and are unable to childmind. Please use the form attached and send to <u>SEYT@education.gg</u> by 6pm for the next day or as soon as possible and we will endeavour to support you.

We appreciate that the sector and other private businesses across the Bailiwick are being affected by the impact of the COVID-19/Coronavirus public health crisis. The message below has been issued to you from Paul Whitfield, States of Guernsey Chief Executive and to our colleagues in schools and post 16. It is being shared to acknowledge his gratitude for your professionalism and hard work at this time. Whilst the references are to our schools the essence of the message is applicable to our sector too. Any further direction for schools, shared by Public Health Services, to advise us of steps that must be taken to minimise contact within the our environments, will be shared and reviewed by our team for you tomorrow, to ensure they apply to our sector.

Please see below a message from Paul Whitfield, to all staff who work in schools, post-16 and early years.

Dear colleagues

I want to thank you all for your continued commitment in supporting efforts to keep our schools open and continuing to focus on the needs of all students. Educating our young people and keeping schools open is a key priority for the island at the moment. It supports other key workers, such as hospital staff, police officers and ports staff who keep our vital supply lines open, and enables much of island life to maintain a degree of normality in what are very abnormal times.

As you will all be aware, there is a rapidly changing international and national picture as a result of coronavirus/COVID-19. In turn this is having a significant impact on the Bailiwick. As we are a small island community, our response is and must be different to other jurisdictions.

The response to coronavirus has been and must continue to be a whole island response. Dr Nikki Brink, Director of Public Health, has advised of the importance of this.

Within this whole-island context, any decision to close schools prematurely could have significant implications:

- In many cases students would be looked after by their grandparents while parents and carers are at work, and the over 65s are our most vulnerable group.
- At a recent meeting, nurses were asked how many of them would have to withdraw from their duties if schools closed and the answer was around 50%.
- Modelling by Public Health shows that schools could be shut for many months if we closed them now.
- Impact young peoples' learning and particularly those at key stages in their school life.

While we cannot underestimate the impact of such decisions, the safety of our children and school staff is of paramount importance. As such further direction, led by Public Health Services, will shortly be issued to all headteachers about steps that must be taken to minimise contact within the school environment. At the moment, the focus in schools must be on the delivery of lessons only rather than the wider school community activity. We will of course share with you the further steps that will be taken to protect staff and students as soon as they are finalised.

We are absolutely not ruling out the possibility that schools may have to close at some stage, however we have to strike the right balance for the island as a whole. I want to thank you again for your professionalism and I also want you to know that your contributions are highly valued. You should not underestimate the significant positive impact that you are having for the Bailiwick during what are challenging times for our whole community.

I am working with various senior civil servants at this time to ensure we have a clear picture as to what school closures would mean for our sector. This includes how we can support the sector from a business perspective during this time and these will be shared as soon as they are available.

Earlier today Deputy St. Pier issued a statement which outlined some financial measures to support the Guernsey economy, the media release can be found here https://gov.gg/article/176828/Financial-measures-to-support-the-Guernsey-economy. Public Health (PH) have updated their advice around mandatory self-isolation for all people arriving onto the islands, enforced from 00:01 on Thursday 19th March – see media release attached, which include emergency enforcement powers.

We continue to follow advice and guidance at https://www.gov.gg/coronavirus and please continue to follow their advice and be reminded that;

'Two dedicated helpline numbers have been released today for Islanders to use if they have **any clinical questions** regarding the coronavirus. The numbers are: **01481 756938 and 01481 756969**

These two numbers will be manned between **8am and 10pm** every day and are being manned by trained call handlers from the Joint Emergency Services Call Centre (JESCC).

Any non-clinical questions that are not answered on this page should be emailed to publichealth@gov.gg'

We appreciate the current circumstances are unprecedented and we want to reassure you we are working with services to ensure you have access to the most up to date information and support to inform your decisions and management at this time.

In addition to continuing to follow guidance from PH, if your ratios and staffing become critical please contact the States Early Years Team (268313) for support and advice in order to ensure the quality of care and safety and security of children is maintained.

If you have members of staff with Qualified Teacher Status then as in the UK ratio's for children 3 years old and older the following will be permitted:

there must be at least one member of staff for every 13 children

Any planned inspections will be suspended until further notice, we will continue to have the ability to carry out unannounced visits should there be a reason to do so (e.g. safeguarding concerns or significant complaint received) as per our regulatory requirements set out in the Children Law (2008) and Child Protection Law (1972). ECERS audits and SER support visits will be discussed with individual providers and a mutual decision will be made as to whether these go ahead. During this time we will continue to work with you to offer support and advice as required.

I am also in contact with the Business Continuity Group within the States of Guernsey who are looking at ways to support businesses at this time and continue to inform them of the unique and essential sector you provide to our islands. I will share any information as soon as I am able to.

Update Coronavirus/COVID-19 - The advice remains as it was on Friday when you were sent the attached email with the further guidance and restrictions around travel.

All updated travel information can be found here https://www.gov.gg/covid19travel. If staff notice that a child becomes unwell with any of the following symptoms (cough, sore throat, running or blocked nose, muscle pain or fatigue or a fever) you should contact their parents to discuss.

If you believe this is a recently developed symptom, in line with Public Health advice on www.gov.gg/coronavirus, than the child should go home and self-isolate until the symptoms have disappeared plus an additional 48 hours.

This remains the advice for staff too, with again the distinction being a **recently developed** symptom.

Please also continue to ensure staff are aware of the latest advice and the importance of everyone reassuring children and parents of it.

As part of Le Rondin School and Centre's risk management of Covid-19 we have been looking at the Business contingency plan. The purpose of this plan is to minimise any risks to the children, families and staff using the centre and what to do if there are any confirmed cases of covid-19.

Le Rondin School and Centre has offices, training rooms and meeting rooms upstairs (referred to as the 'Centre'), however, we share an entrance with the children and staff from the school. Some of these children are particularly vulnerable in these circumstances. Please, therefore, ensure you adhere to the Public Health guidance of hand washing and hygiene before you come into the centre and only come into the centre if you are required to and are not displaying symptoms as outlined by Public Health advice. If you can communicate via email or telephone please do so. All training booked in is currently still going ahead, unless we are advised otherwise and we will contact all individuals if this is the case and let them know.

If there are to be any closures either of the school and not the Centre or both the school and the Centre we will let you know, including contact numbers should the Centre be closed.

We will contact you with further guidance as the situation develops.

Following on from our email yesterday regarding the Coronavirus/COVID-19 update, please see the recent Public Health Services new guidance issued late yesterday afternoon which could be sent to parents:

As some of you may have seen, Public Health Services issued new guidance late yesterday afternoon around when people should self-isolate. The advice from Public Health is now that, as an extra layer of caution to protect our community, anyone who <u>becomes</u> unwell with the following symptoms (cough, sore throat, running or blocked nose, muscle pain or fatigue or a fever) should stay at home and self-isolate until the symptoms have disappeared <u>plus an additional 48 hours</u>.

If your child BECOMES unwell with any of these symptoms, please follow the latest advice and keep them at home

Please note that should your child <u>become</u> unwell they would not need to be tested for coronavirus/COVID-19 unless they have recently travelled to a Group A or B country (you can find these here <u>www.qov.qq/coronavirus</u>).

This new advice from Public Health Services represents good infection prevention control at any time, but is particularly important while the Island is working to contain the spread of COVID-19. Evidence proves that this advice could reduce the potential spread of respiratory illness by 60%.

Should you/staff notice that a child has become unwell with any of these symptoms, we will contact you in the first instance to discuss and they may be required to come home.

Please can you reprioritise your daily schedule wherever possible to allow time to clean down high contact surfaces in social areas and toilets. This can be done with the products you use daily. Please ensure you cover all areas that children and staff touch regularly (door knobs, taps, reception front desk, hand rails etc.).

Also attached is the latest version of advice that has been sent to schools from Public Health Services, please familiarise yourself with the contents but as it could be constantly updated for future use please ensure you have looked at the latest version available at https://www.qov.gg/coronavirus.

The States Early Years Team would ask you to use your professional judgement and holistic knowledge of your children and continue to be vigilant with hand washing and cleaning. We appreciate this is a difficult time for all families and staff teams, but please follow guidance from the World Health Organisation and our Director of Public Health who are updating information as it comes through.

As a private business please check your own policies and guidance for parents and ensure you refer to current medical advice to ensure they align and share any updates with parents. If a parent/carer choses to take their child out of your provision when they have not become ill with any of the symptoms as advised, then depending on the contract you have in place, they may still be required to continue to pay. It would be advisable to check your contracts. As a private business it is your decision to make, but please ensure you are following the Public Health guidance to help make an informed decision.

Providers who offer the Preschool Education Funding will continue to be paid as you continue to follow the advice from Public Health.

It is also essential that we continue to keep our children and staff safe and we must therefore ensure at this time we continue to work within ratios, this may mean you are required to move staff as necessary.

Schools have been advised to share this with their parents/carers, to reassure them about steps that will be taken in the event that any child/member of staff are experiencing symptoms linked to coronavirus:

Given the heightened awareness about coronavirus/COVID-19 both globally and locally following the island's first confirmed case this week, as the Early Years Sector we should prepare ourselves for the likelihood that there will be times in the days and weeks ahead when children or staff are sent home <u>as a precaution and on the advice of Public Health Services</u>.

We have already seen a few such instances across our schools and it is really important that we are aware of the most up-to-date advice and avoid causing unnecessary distress through speculation.

Please be assured that if a child experiences relevant symptoms (**fever, cough or shortness of breath**) we will speak to Public Health Services and take their advice on any actions needed. It is vital that we <u>remain calm</u> and take proportionate steps to support the efforts of Public Health Services. Given the time of year, anyone experiencing symptoms could be suffering from flu or another illness so it is important not to jump to conclusions.

We will of course contact you straight away if there are any material changes to circumstances. However, please note that we are unlikely to contact all parents if a child experiences symptoms and is sent home as a precaution. As we are expecting that this may well occur in the coming days or weeks, we wanted to write to you all now so that as the Early Years Sector we are all on the same page regarding both the advice we should all listen to and the expectation that there are likely to be times when children are sent home as a precaution on the advice of Public Health.

At this stage there is no need for any further action, there are no plans to close early years providers and there is no need to keep children away from early years settings.

I would encourage everyone to read up on the latest advice which can be found at www.gov.qq/coronavirus.

In terms of general advice; should anyone experience any of the three symptoms (fever, cough or shortness of breath) and have the relevant travel history (see www.gov.gg/coronavirus), they should contact the coronavirus helpline for advice.
