States of Guernsey: Extant Resolutions – Ongoing Principles

Introduction

The table below captures the extant Resolutions of the States of Guernsey (as at 2nd June 2023) that are Ongoing Principles. These are Resolutions that require action; however, this action has no defined endpoint and is seen as an ongoing consideration. For example: ‘To direct all Committees when formulating policy to take account of long-term impacts on the wellbeing of current and future generations.’
