#### **SCRUTINY MANAGEMENT COMMITTEE**

### TRIBUNAL OF INQUIRY P.2020/24

- I. After consideration of the Policy Letter entitled 'Tribunal of Inquiry', dated 11 February 2020:
  - 1. TO NEGATIVE THE PROPOSITION to resolve it is expedient that a Tribunal of Inquiry be established in accordance with the Tribunals of Inquiry (Evidence) (Guernsey) Law, 1949, as amended, to inquire into a matter of urgent public importance, namely the establishment of the facts and circumstances surrounding appointment to the post of Head of Curriculum and Standards in accordance with the following Terms of Reference:
    - a) to inquire into the circumstances leading up to and surrounding the appointment of the Head of Curriculum and Standards;
    - b) to examine whether the appointment made conformed to the current policies and procedures of the relevant Committees of the States of Guernsey;
    - c) to examine whether good governance standards were maintained during the appointment process;
    - d) to examine such other associated relevant matters as the Tribunal may think fit; and
    - e) to make such recommendations as the Tribunal considers appropriate.
  - 2. TO NEGATIVE THE PROPOSITION to direct the Scrutiny Management Committee to request the Royal Court to appoint an individual or individuals to constitute the Tribunal of Inquiry.
  - 3. TO NEGATIVE THE PROPOSITION to delegate authority to the Policy & Resources Committee to approve expenditure as required up to £150,000 in order that the Tribunal of Inquiry may be established and discharge its functions.
  - 4. TO NEGATIVE THE PROPOSITION to resolve that the Tribunal of Inquiry should forward its resultant report to the Presiding Officer of the States of Deliberation for publication as an appendix to a Billet d'État.

### DEVELOPMENT OF COMPETITION LEGISLATION P.2020/17

VII: After consideration of the Policy Letter dated 30<sup>th</sup> January 2020:-

- 1. To agree to amend the definition of 'merger or acquisition' and 'joint venture' as set out in paragraphs 4.1 to 4.5;
- 2. To agree to repeal the provision that no right, title, or interest shall pass in any property or shares on transactions that have not been notified to the Guernsey Competition and Regulatory Authority (the "GCRA"), and replace it with an ability for the GCRA to impose financial penalties for failure to notify a transaction that attracts mandatory notification, as set out in paragraphs 4.6 to 4.8;
- 3. To agree to insert an explicit exemption regarding the transactions set out at paragraphs 4.9 to 4.11, relating to financial institutions; and
- 4. To direct the preparation of such legislation as may be necessary to give effect to the above decisions.

# TRANSFORMING INCOME TAX AND CONTRIBUTIONS SERVICES – THE FINAL PHASE OF THE REVENUE SERVICE PROGRAMME P.2020/20

VIII: After consideration of the Policy Letter entitled "Transforming Income Tax and Contributions Services – the Final Phase of the Revenue Service programme", dated 4<sup>th</sup> February, 2020:-

1. To delegate authority to the Policy & Resources Committee to approve a Capital vote of a maximum of £12.1m to fund the next phase of the Revenue Service programme. Funding will be divided between the Capital Reserve and the

Guernsey Insurance Fund in a presumed 2:1 split, with the final split agreed by the Policy & Resources Committee and the Committee *for* Employment & Social Security at the end of the phase. Funding will be released in stages and on approval of the necessary documentation.
