Directorships held by me

- 1. Victory (Guernsey) Limited. The registered office is The Albany, South Esplanade, St Peter Port. This company owns Victory House, Le Pollet, St Peter Port (where the Bangladeshi Restaurant is) which it rents out. It is a property-owning company. I receive no remuneration as a Director. I own 50% of this company.
- 2. Lutine Holdings Limited. The registered office is at the premises of NSM Trust in St Peter Port, Guernsey. I and my family have no beneficial interest in this company. I do receive remuneration as a Director. I am a Director in my capacity as a Trustee. Lutine Holdings Limited is the ultimate holding company for a small group of companies.
- 3. The Scott Family PTC Limited. The registered office is at Mill House, St George's Esplanade, St Peter Port. It is a private run trust company. I am a Director in my professional capacity and I am remunerated as a Director.
- 4. Ferchan Limited. Its registered office is at Warwick House, Le Pollet, St Peter Port. It is a trading company in the hospitality industry in Guernsey. The company is controlled/owned by myself and members of my family. I receive no remuneration as a Director.
- 5. Rocquaine Properties Limited. Its registered office is at The Albany, South Esplanade, St Peter Port. It is a property-owning company. It owns the Pearl Centre at Rocquaine, St Peters, and the adjoining premises on the same site. These premises are rented out. The Pearl Centre to a private business and the adjoining premises to the States of Guernsey where they keep the maritime wreck. The company is owned 50%. I receive no remuneration as a Director.
- 6. Beauvoir Group Limited and associated companies. The registered offices are in St Peter Port. The Group operates a fiduciary business. I own 10% of this company. I receive no remuneration as a Director.
- 7. Rich Man Poor Man Limited. The registered office is at Les Granges de Beauvoir Manor, lvy Gates, St Peter Port. It owns 'Arcachon', Bosq Lane, St Peter Port which is rented out as staff quarters. I own 100% of this company.
- 8. Tarian Trust Limited. The registered office is at 'Rosewood', The Grange, St Peter Port. It is a Fiduciary/Trust provider. I am remunerated as a Director. I have no beneficial interest in the company.
- 9. Cranley Property Company Limited. The registered office is at 'Les Granges de Beauvoir Manor', Ivy Gates, St Peter Port. It owns residential properties opposite Valnord States Houses and residential properties leading down to the Water Lanes. It is a property-owning company. All the properties are rented out. I own 40% of this company and receive quarterly dividends.

Directorships held by my wife Glenda Ferbrache. For ease of convenience I have carried on the numbering. The first company of which she is a Director is thus number 10.

- 10. Guernsey Building Developments Limited. The registered office is at The Albany, South Esplanade, St Peter Port. It is a property-owning company. It owns the Manor Hotel, Petit Bot, Forest, and a cottage on the opposite side of the road. These are rented out. I own one-third of this company. My wife receives no remuneration as a Director.
- 11. New Carlton Hotel (Guernsey) Limited. The registered office is at The Albany, South Esplanade, St Peter Port. It is a property-owning company. It owns the Carlton Hotel/Inn, La Route des Cornus, St Martins. It is rented out. I own one-third of this company. My wife receives no remuneration as a Director.
- 12. Rich Man Poor Man Limited. The registered office is at 'Les Granges de Beauvoir Manor', Ivy Gates, St Peter Port. See 7 above.
- 13. Holfer Limited. The registered office is at Warwick House, Le Pollet, St Peter Port. It is a property-owning company. It owns The Chop House Restaurant, 35 Le Pollet, St Peter Port. It is rented out. It is 100% owned by myself. My wife receives no remuneration as a Director. She is also the Company's registered agent.
- 14. Rocquaine Properties Limited. See 5 above for details. My wife receives no remuneration as a Director.
- 15. Crabby Jack Holdings Limited. Its registered office is at Warwick House, Le Pollet, St Peter Port. It is a property-owning company. It owns Crabby Jacks Restaurant and staff quarters at Vazon, Castel which is/are rented out. It is 100% owned by myself. My wife receives no remuneration as a Director.
- 16. Capital Restaurants Limited. Its registered office is at Warwick House, Le Pollet, St Peter Port. It is a trading company. It operates a restaurant known as The Boathouse in St Peter Port which is leased from the States of Guernsey. The company is owned as to 75% by myself. My wife receives no remuneration as a Director.
- 17. Petal Limited is a property-owning company. It owns and rents out a lodging house known as 'Petit Haven', Hauteville, St Peter Port. Its registered office is at 'Burghley House' 5 Clos de Verger, Ville au Roi, St Peter Port, Guernsey, GY1 1NZ. It is owned 50% by myself. My wife receives no remuneration as a Director.
- 18. Capital Restaurants Properties Limited. Its registered office is at Warwick House, Le Pollet, St Peter Port. It owns a property (a lodging House/staff quarters) known as 'Caledonia Lodge', Valnord, St Peter Port. It leases that property out. It is owned 100% by myself. My wife receives no remuneration as a Director and is also the Company's registered agent.
- 19. Ferchan Limited. See 4 above for particulars. My wife receives no remuneration as a director.

- La Tourelle Limited. My wife receives no remuneration as a Director. This owns two
 residential properties occupied by family members.
- 21. PFHH Limited. The registered office is at Warwick House, Le Pollet, St Peter Port. It is a property-owning company. It owns Allez House, Allez Street, St Peter Port. The property is rented out as staff quarters. The company is owned 100% by myself. My wife receives no remuneration as a director.
- 22. Superbowl Property Holdings Limited. The registered office is at Warwick House, Le Pollet, St Peter Port. It is a property-owning company. It rents the property out as staff quarters. The property is Hollytree House, Allez Street, St Peter Port. I own 100% of the company. My wife receives no remuneration as a Director and she is also the company's registered agent.

APPENDIX B

- 'Les Granges de Beauvoir Manor', Ivy Gates, St Peter Port. This is owned by myself. It is my principal residence.
- The Vinery, Le Gele Road, Castel. This is owned by myself. It is a commercial vinery and is rented out.
- 3. 'La Tourelle', La Rue Traversée, Route de Cobo, Castel. This is owned by La Tourelle Limited which is owned by my wife. It is a residential property.
- 4. 'Manor View Bungalow', Ruette de la Tour, Castel. This is owned by La Tourelle Limited. It is rented/leased out. It is a residential property.
- 5. 'Ivymount', Mount Durand, St Peter Port. This is owned by myself as to an undivided one-half share, the other half is owned by a third party.
