Notes on the conditions concerning the playing of Crown & Anchor as contained under the provisions of The Gambling (Crown & Anchor) (Guernsey) Ordinance, 1983, as amended

- The Office of the Committee for Home Affairs requires written permission of the <u>Constables</u> of the said parish and also a written statement signed by the <u>Occupier</u> of the land on which the said event is to be held or by a person authorised by him in that behalf to the effect that the occupier has no objection to the playing of Crown and Anchor at the event, <u>before the said</u> <u>permit is issued</u>.
- 2. Crown and Anchor shall be played **only** at an event of the following nature, that is to say:
 - a) Agricultural or Horticultural Shows;
 - b) Meetings for the purpose of horse racing;
 - c) Regattas; and
 - d) Other events held where the event includes participation in or support of sports, games or cultural activities, or the main objective of the event is to raise proceeds that are devoted to purposes other than purposes of private gain.
- 3. The game shall be conducted only by a person who is the holder of an Operator's Licence, which for the time being is in force.
- 4. No person under the age of eighteen years shall take part in the playing of the game.
- 5. The games shall be played only under and in accordance with the conditions of a Table Permit issued to the promoter of the event by the Home Department, these conditions being as follows:
 - a) That the game shall **not** be played on Good Friday or Christmas Day.
 - b) That the game shall **not** be played between the hours of 11.00 pm and 9.00 am.
 - c) That the game shall **not** be played on more than three days at any one event.
 - d) That the Table Permit and the Operator's Licence shall be clearly displayed on, or adjacent to, the Table.
 - e) That no person under 18 years of age shall play CROWN AND ANCHOR, and that a sign to this effect of acceptable condition and in characters of not less than inch in height shall be clearly displayed.

The data controller for the information collected on this form is the Committee *for* Home Affairs and it is being collected so that the controller is able to comply with its duties under the Gambling (Cinema Racing), 1988. All information provided will be processed in accordance with the Data Protection (Bailiwick of Guernsey) Law, 2017. The information collected on this form is being regarded as your personal data and the legal basis upon which the information is being collected is to allow the controller to comply with a Law, this is in line with the condition provided by Schedule 2 (8) of the Data Protection (Bailiwick of Guernsey) Law, 2017. The data will only be used by the Committee for Home Affairs and will not be shared with third parties. The data will be stored securely, appropriate organisational and technical safeguards will be implemented, and all information supplied will be destroyed after a period of two years.
