None of the above sexual crimes had a cyber flag as per the HOCR definition - Online flag definition: An offence where the reporting officer believes that on the balance of probability, the offence was committed, in full or in part, through a computer, computer network or other computer-enabled device.

NB. The States of Guernsey have drafted (but not set in legislation yet) a new Sexual Offences Law which will incorporate offences such as online grooming. Currently these types of offences are investigated under other Laws such as Mis-use of Telecommunications Law.
