## **Request for information:**

I am looking to find the statistics for hate crimes in the island. I have spoken with the Police and they have said that request needs to be put in with yourselves.

We are particularly looking at the breakdown of any incidents related to homophobia, transphobia and racism. We are looking to run a project across the island to highlight some of the issues with these, especially within schools as there has been a rise in homophobic and racist incidents there. We are looking to see what information there may be on the prevalence of these issues in general society. However, my understanding (form the police) is that it is at the discretion of the officer to log any incidents as being motivated by 'hate' and sometimes these just get noted as 'assault' but not the reason behind the assault.
