

List of Licenced, Controlled and Prohibited Pesticides in Guernsey **November 2022**

Certain pesticide products have been assessed as too a high risk for use in Guernsey due to their toxicity, persistence in the environment or impact on our raw water quality.

- Pesticides approved in the UK or other jurisdictions may not always be approved for use in Guernsey.
- Products available online may not always be approved for use in Guernsey.
- Old stocks of pesticides may no longer be approved for use.

1a. Licenced Pesticides/ Biocides

The following active ingredients currently have UK approval but can only be used under licence in Guernsey as they are considered a higher risk to people or the environment.

Bendiocarb	FICAM D (1.25% powder)	UK 2018-1136	Asian hornets	Approved as a biocide in UK and can be licenced for control of Asian hornets (professional use only) in Guernsey. Must not be used on crops, food products and in occupied buildings.

EAMUs* (Extension of Approval for Minor Use) are at the Growers risk and can only be used under the conditions and rates specified in the EAMU and on the product label.

1b. Licencing of Products Approved in & Imported from Other EU Countries

Under certain circumstances products approved in other EU countries can also be considered for licencing. The product would need to be approved for the same intended use in an EU country already. The following is an example which may be considered on that basis if a real need was identified.

1. Controlled Pesticides – Glyphosate herbicides

From 31st December 2022 the purchase and use of all **GLYPHOSATE** based products (garden and professional formulations) will be restricted to persons holding a recognised Certificate of Competence in the safe use of pesticides. These measures have been implemented to protect the quality of the Island's raw water supply and protect the wider environment following increases in levels being detected.

There are currently 155 garden products and 270 professional products approved for use in the UK that contain glyphosate [Databases Home Page \(hse.gov.uk\)](https://www.hse.gov.uk/databases/home-page/) which will be subject to these controls.

2. Approved UK Pesticides but Prohibited in Guernsey

All products containing **Aluminium Phosphide, Aminopyralid, Picloram, Chlorpyrifos or Chlorpyrifos-methyl** are banned in Guernsey as they are considered to pose and unacceptably high risk to people or the wider environment.
