Face masks

Health and Social Care (HSC) bases its operational policies in respect to the wearing of facemasks on NHS guidelines and information from Public Health colleagues in the Bailiwick. Facemasks have been worn at the acute hospital and across other health and care settings in the Bailiwick routinely, including prior to the Covid-19 Pandemic and during winter pressures to help reduce the spread of infection and to support business continuity.

During outbreaks of Covid-19 at the Princess Elizabeth Hospital and in community health and care settings a number of services may revert to the wearing of face masks for all staff and visitors as part of non-pharmaceutical interventions (NPIs), including vaccination and handwashing etc. It is important to note that this can be across HSC services and other partner health and care providers.

To support risk assessment and decision making there is a multi-disciplinary operational network made up of senior colleagues across HSC, Medical Specialist Group and external providers such as Primary Care and St John Ambulance and Rescue. The network considers data and information from Public Health on the current trends in Covid-19 cases and other respiratory virus infections in the Bailiwick. HSC has its own internal triggers, to initiate mask wearing in the hospital and these are reviewed regularly. This multi-agency group assess the risk to service disruption and are responsible for determining if face masks should be used across its areas of service provision. Equally other key partners from the operational network will make risk based decisions for their

own areas of practice. It is important to note that mask wearing is stepped up and stepped down as appropriate to protect critical services.
