- Current Use Class (if requested);
- If the property is a protected building;
- If there is a protected tree and/or protected monument on the land;
- Zoning of the land.

9b. Enhanced property search for a domestic property

The search comprises as 9a above, plus:

- Planning history prior to 2002 (accessing archive files as necessary)
- Building Control history prior to 2002 (accessing archive files as necessary)

9c. Appointment to view file details (domestic) - A half hour appointment with a member of staff in addition or instead of the above where plans, decision notices and other related information can be viewed. The enquirer may make their own notes.

Building Control History will include details of approval or rejection of full plans, including modifications or conditions imposed, and issuing of licences, compliance and other enforcement notices served and issue of completion certificates.

The search applies only to the property for which it is requested and to no other property. The searches will not deal with covenants, rights of way, boundaries or other such legal/conveyance issues. Once all required information has been completed a written report will be sent by post.
