(NB Paragraphs (1), (4) and (5) of Rule 20 of the Rules of Procedure of the States of Deliberation provide:
"(1) The elections held quadrenially following each General Election of People's Deputies shall be held in the following order:
(a) Chief Minister
(b) Ministers
(c) one of the Ministers as Deputy Chief Minister
(d) Chairmen of Committees
(e) Members of Departments
(f) Members of Committees
(g) Chairmen and Members of Non-Governmental Bodies
and the Chief Minister shall determine the order in which the Ministers and Chairmen are elected which same order shall be followed in electing Members of Departments and Committees.
(4) On a proposition to elect a Minister or a Deputy Chief Minister the Presiding Officer shall first invite the Chief Minister, and thereafter other Members, to propose eligible candidates. Nobody shall speak about a candidate at that stage; and if only one candidate is proposed and seconded the Presiding Officer shall put the election of that candidate to the vote without speeches. If there is more than one candidate the Presiding Officer shall invite the proposers and the candidates to speak for not more than 5 minutes each before voting takes place; and no member other than a proposer or candidate shall be entitled to speak.
(5) On a proposition to elect a Chairman of a Committee the Presiding Officer shall invite Members to propose eligible candidates. Nobody shall speak about a candidate at that stage; and if only one candidate is proposed and seconded the Presiding Officer shall put the election of that candidate to the vote without speeches. If there is more than one candidate the Presiding Officer shall invite the proposers and the candidates to speak for not more than 5 minutes each before voting takes place; and no member other than a proposer or candidate shall be entitled to speak."

As the Chief Minister will not be elected until ${ }^{\text {st }}$ May, 2008, the elections for Ministers and Chairmen of Committees have been listed in alphabetical order. At the States Meeting the Chief Minister may request the Presiding Officer to call the elections in the order he has determined.)
(NB Elections in respect of Special States Committees and Non-Governmental Bodies will take place at the Meeting of the States of Deliberation to be held on Wednesday, the $28^{\text {th }}$ May, 2008.)
