Personal property belonging to natural persons transferring their normal residence from a third country to the Customs Union may be admitted free of import duty.

This relief does not apply to –

- a) alcoholic and tobacco products,
- b) commercial means of transport,
- c) other commercial goods.

Note: - Your normal home is regarded as the place where you usually live for at least one hundred and eighty-five (185) days in a period of twelve (12) months because of your personal and occupational ties.

The countries of the Customs Union are:-
United Kingdom, Isle of Man & the Channel Islands.

Importers' Declaration

ANY UNTRUE STATEMENT MAY LEAD TO PENALTIES AND FORFEITURE OF THE GOODS CONCERNED.

I declare that –

- a) I am removing my residence to the Bailiwick of Guernsey,
- b) I have been resident outside the Customs Union for a continuous period of at least twelve months,
- c) I have owned and used the personal and household effects for a minimum of six months,
- d) The personal and household effects are intended to be used in my new normal place of residence, and that they will be retained by me for my own personal use.

If NONE write 'NONE' against each item of the category of goods listed below.

***Prohibited goods**

There are some goods that you cannot bring into Guernsey. They will be seized by Customs and you may be prosecuted. These goods include:

- Illegal drugs – such as heroin, cocaine, cannabis and derivatives, synthetic cannabinoids, amphetamines, ketamine,, LSD and MDMA (ecstasy)
- Offensive Weapons – such as flick knives, butterfly knives, knuckledusters, sword sticks, batons, throwing stars, samurai swords and some martial arts equipment
- Self-defence sprays i.e. pepper spray, CS gas, mace
- Electric shock devices such as stun guns
- Indecent and obscene materials

****Restricted goods**

Some goods are restricted and you will need a specific licence to bring them into Guernsey. Without such a licence they may be seized by Customs and you may be prosecuted. These goods include:

- Firearms and component parts of firearms, ammunition and explosives (including fireworks)
- Animals & Birds
- Certain medicinal products (including prescription medication)
- Cash including bullion, travellers cheques and precious metals
- Endangered Species whether alive or dead, including goods made from them like fur, ivory and reptile leather.
- Uncooked meats and poultry
- Certain plants, trees, shrubs, potatoes, fruit and vegetables
