REQUÊTE

SUNDAY TRADING

THE HUMBLE PETITION of the undersigned Members of the States of Deliberation SHEWETH THAT:-

- 1. The Sunday Trading Ordinance 2002¹, as amended was approved by the States of Deliberation at their September 2002 meeting, in pursuance of their Resolutions of the 11th November, 1999² and 27th March 2002³, and in exercise of the powers conferred on them by sections 1, 2, 3 and 4 of the Sunday Trading (Guernsey) Law, 1973⁴.
- 2. The Sunday Trading Ordinance prohibits shops from opening on a Sunday unless they are licensed or open for an exempt purpose as defined in that legislation. In the opinion of your petitioners, since the enactment of that Ordinance, there has been progress towards a greater fairness regarding Sunday trading brought about by licences and changes allowing the sale of fuel, alcohol and other items. These changes are popular and further changes should follow.
- 3. Further, in the opinion of your petitioners, the current regime allows wide discretion by the Constables and Douzaine of the Parish in which a shop is situated and to whom licence applications are made. Subject to the provisions of the legislation, the relevant Constables and Douzaine are in theory entitled to license large non food retail outlets. Your petitioners believe that this is illogical and inconsistent so that a pan Island regime should be implemented.
- 4. It appears to your Petitioners that the people of Guernsey are divided on these matters not only in terms of religious and philosophical convictions but also in terms of perception of the likely implications; but that in the modern history of Sunday trading there has never been a period of total de-regulation on which the reality of those implications can be objectively judged. In the opinion of your Petitioners, therefore, it would be appropriate to suspend the operation of the Sunday Trading Ordinance, 2002 as amended, for a trial period of 12 calendar months, commencing from 1st December 2012, during which data concerning Sunday trading should be collected from relevant businesses, consumers and other relevant organisations and local opinion should be canvassed; and then the States can make better informed decisions for the future.

THESE PREMISES CONSIDERED, YOUR PETITIONERS humbly pray that the States may be pleased to resolve as follows:

- a) To direct the preparation of such legislation as may be necessary to suspend the operation of the Sunday Trading Ordinance, 2002 as amended, for a trial period of 12 calendar months commencing 1st December 2012,
- b) To direct the States Commerce and Employment Department to collect data from relevant businesses, consumers and other relevant organisations and to canvass local opinion during those 12 months concerning the social, economic and other consequences of the suspension, and to report back to the States as soon as possible with its conclusions and any recommendations arising therefrom.

Requête - Sunday Trading

Thank you for your letter of 13th September requesting the views of the Department on the subject matter of this requête.

The Department's view on the general topic of the examination of possible changes (including the option of the removal of restrictions on trading on a Sunday entirely) was established and communicated earlier this year. By a majority, members do not consider the topic of Sunday Trading (or a review of it) to be of sufficient practical economic importance to the Island for it to be given a priority for action at the present time.

The Department's preference was, and remains, that the process of review and wide consultation should not be started at the present time, but would be considered for inclusion in a future Departmental business plan, on its merits at the time.

It was noted that the requête is seeking a trial period for twelve months and Board Members commented that such a proposal is an unusual approach and precedent. Changes to legislation are normally considered against the merits or otherwise of those changes.

Members also noted that the requête, if accepted in its current form or something similar, will necessarily bring about the situation where the currently postponed review will have to commence at some time in 2013 and be concluded in 2014.

Further, Members have noted and have concerns that some of the wording of the requête does not reflect the reality of the legislation. In particular, concern was expressed over the suggestion in paragraph 3 of the requête that the current legislation allows "wide discretion" to parishes when considering applications, which it does not. In an allied point it is suggested that the current system is not a "pan Island" one. Again, this is quite at odds with the approach, agreed in 2002 and set out in the Ordinance, for a uniform and centrally guided – albeit Parish administered - set of restrictions in line with views of the expectations and needs of Island society.

A majority of members are also concerned that the timings in the current form of the requête (a 12 month suspension of the powers in the Ordinance from December 2012 to

November 2013 inclusive) will create uncertainty and potentially unnecessary work and expense for Island Douzaines, island traders and staff at the Department.

Sunday Trading Licence applications for the following year are typically made in October, November and December and depending upon when the requête is debated and the outcome this could lead to a need to continue to process licence applications for 2013 (at a non-refundable cost of £25 to each shop). As the requête is currently drafted, licences will be needed for the month of December 2013 as well as for all of 2014. The Ordinance currently requires that these are separate licences as each one expires at the end of each calendar year (i.e. December).

Finally, Board Members are concerned over the rights of shop workers under the Employment Protection (Sunday Shop Working) (Guernsey) Law, 2001 (the SSWP Law). Whilst this Law provides protection to some shop workers who do not wish to work on Sundays, under certain circumstances workers may initially have to work on some Sundays until completion of a statutory notification period which has to be given to their employer advising of their wish to opt out. In practice this period of notice may be between one and three months depending on the wording in the employee's terms and conditions of employment.

Again, the short notice of change arising from the wording of this requête has the potential to create uncertainty for businesses and for workers regarding shop worker protection and the requirement to work on Sundays, if requested to do so.

To try and ensure that there is an informed debate when this comes to the Assembly, the Department intends to provide States Members with some factual briefing notes which will explain in greater detail the provisions of the SSWP Law and also of the Sunday Trading Ordinance, 2002 itself.

Thank you for your letter dated 13th September seeking the Department's comments on Deputy Hadley's proposal to trial Sunday opening.

Sunday Trading Requête

Thank you for your letter dated 13 September 2012, requesting the Home Department's views on the above Requête, proposing the suspension of the Sunday Trading Ordinance 2002, as amended, for a trial period from 1st December 2012.

Whilst the Sunday Trading Ordinance 2002 has no direct impact on the Home Department, since the Requête has been submitted the Department has been approached by individuals regarding its impact on liquor licensing legislation and local gambling legislation. For the avoidance of doubt, the Department wishes to clarify that the proposed suspension of the Sunday Trading Ordinance will not override the existing provisions contained within the Gambling or Liquor Licensing Legislation and the provisions set out within those will stay namely;

- The liquor licensing legislation for off sale premises draws no distinction between Sundays and other days with liquor sales permitted between 7:00am and midnight. In practice, a significant proportion of off sales currently do not trade on Sundays either as they fall foul of the Sunday Trading Ordinance due to size or whilst small enough to potentially open, subject to the grant of the relevant permit, have made a commercial decision not to. Should the Sunday Trading Ordinance 2002 be temporarily suspended it may be that more off licences would open and trade on Sundays and would be able to do so in accordance with their current licence.
- The Gambling legislation prohibits bookmakers opening on a Sunday and this will continue to be the case irrespective of the States decision on the Requête

Other than the above clarification, the Home Department feel that the issue of Sunday opening is a matter of individual conscience for Board members rather than one on which the Home Department has a collective view.

The Douzaine of St Martin has discussed Deputy Hadley's Requête regarding Sunday trading.

The Douzaine does not support the Requête. They believe that the removal of the restrictions will result in increased costs for the trader which will no doubt be passed unto the consumer through higher prices.

In addition our concern is that these additional costs will be more easily absorbed by the larger businesses and put further pressure on the smaller establishments. This will of course be in addition to the pressure on the smaller businesses to open if they are in competition with the larger organisations as any loss of business will reduce their ability to continue trading.

The smaller businesses give St Martin, and the island as a whole a unique character, that if lost would be to the detriment of St Martin and Guernsey.

The Douzaine does not have a problem with Sunday being different to the other days of the week and again gives the island its own character.

The Douzaine do not have a problem with continuing to be responsible for granting Sunday Trading licences.

While there may be some anomalies with the existing legislation the Douzaine believes the current situation to be far better than the two extremes of no trading or no regulation. The existing legislation is 'Guernsey Common Sense' at its best, where it seeks to balance convenience and protection of staff and smaller businesses, providing a variety and quality of life that makes St Martin and Guernsey such a special place to live.

Thank you for your letter dated 13th September 2012 seeking the views of the St Saviour's Douzaine concerning Sunday Trading.

We have has consistently opposed the opening of all large shops on Sundays and can see no reason to change this opinion in light of a Requête from Deputy Hadley.

We believe that Guernsey Sundays have a completely different feel about them to the other days of the week. Families, groups and individuals have a more relaxed outlook on these days and engage in a range of activities in an altogether different manner. We have no desire to see this change.

As far as business is concerned, opening all shops on a Sunday is not going to generate any additional trade. Guernsey people will have no additional money to spend simply because shops might be open on Sundays. Retailers will incur one sixth additional costs to generate, what in all likelihood will be, a similar income. This Requête, if successful, will result in the States giving the green light for an increase in the cost of operating a retail outlet in Guernsey and making such businesses less profitable.

If the Requête is successful we would find it at odds with the recent States' decision that resulted in a reduction of postal deliveries from six days to five at Guernsey Post Limited (a Company in which the States have a financial interest) in order to make the Company more profitable.

If Sunday trading is allowed, we believe that it will result, eventually, in all retail businesses having to follow the lead of the big UK-based multiples, who will be unable to resist operating as they do on the mainland.

The Douzaine sympathises with those lower paid members of our society who work in the retail industry and would feel pressure to work on a Sunday while others, better paid e.g. Office workers, Lawyers, Doctors etc are not prepared to provide their normal service on a Sunday. The Douzaine is aware that the cost to see a doctor in Guernsey doubles on a Sunday. Professional people do not seem to be shouting from the rooftops that they wish to work on Sundays.

We hope that you find these comments helpful.
