PROJET DE LOI

ENTITLED

The Plant Health (Enabling Provisions) (Guernsey) Law, 2014

THE STATES, in pursuance of their Resolution of the 27th April, 2006^a, have approved the following provisions which, subject to the Sanction of Her Most Excellent Majesty in Council, shall have force of law in the Islands of Guernsey, Herm and Jethou.

General power to make Ordinances protecting plant health.

1. The States may by Ordinance make such provision as they think fit to protect plant health, by –

- (a) the regulation of the importation into and export and re-export from Guernsey of plants, plant products, and plant pests, and
- (b) any other provision which has the purpose of preventing the introduction of, and where already present, preventing or controlling the spread of noxious, invasive or otherwise harmful plants, or plant pests.

Specific matters for which Ordinances may make provision.

2. (1) An Ordinance under section 1 may, without limitation, make provision in relation to the following matters –

- (a) prohibiting the importation into Guernsey of specified plants, plant pests and plant products,
- (b) prohibiting the importation into, export and re-export from and movement within Guernsey of specified plants, plant pests and plant products not accompanied by a phytosanitary or other specified certificate, or another specified document,
- (c) imposing other requirements or restrictions relating to the importation into and export and re-export from Guernsey of specified plants, plant pests and plant products, including (but not limited to) –
 - (i) the prohibition of imports into and exports and re-exports from ports and airports other than those designated by the Department for the purpose,
 - (ii) requirements relating to marking and certification, and the presentation and display of documents, and
 - (iii) requirements relating to advance notification of imports,

- (d) providing for the appointment of officers by the Department, referred to in this Law as "**plant health officers**", and for plant health officers to have powers for the purpose of preventing and controlling the introduction and spread of noxious, invasive and other harmful plants, and plant pests; including (but not limited to) –
 - (i) entering and inspecting premises,
 - (ii) inspecting and copying documents,
 - (iii) monitoring, taking samples from, seizing, treating and destroying plants and specified material, and
 - (iv) serving notices in relation to the same,
- (e) providing for the designation of control areas, the removal from which of specified plants, plant pests and plant products may be prohibited or restricted,
- (f) providing for the issue by the Department, and by persons authorised in that regard by the Department, of documents and labels relating to –
 - (i) plant health generally, and

(ii) the importation into, export and re-export from, and movement within Guernsey of plants in particular,

and for the Department to impose requirements regarding the use of such documents and labels,

- (g) empowering officers of Customs and Excise to inspect and detain specified containers, packages and cargo,
- (h) prohibiting the keeping, storing, selling, moving or otherwise disposing of specified plants, plant pests and plant products,
- (i) establishing a register of plant traders, prohibiting specified activities by persons other than persons registered as plant traders, and making other provision and imposing other requirements in relation to such a register and registered persons, including (but not limited to) the payment of fees and charges,
- (j) requiring specified persons to notify the Department, a plant health officer or any other specified person of specified matters, including (but not limited to) the presence or suspected presence of specified plants and plant pests, and in such circumstances to take other specified steps with the purpose of preventing or controlling the spread of noxious, invasive or otherwise harmful plants, and of plant pests,

- (k) empowering the Department (acting through plant health officers or otherwise), in circumstances where there has been an outbreak of a specified plant pest in Guernsey, or where such an outbreak is suspected, to take steps aimed at controlling that outbreak ("**containment measures**"), including (but not limited to) –
 - (i) regulating access to designated areas,
 - (ii) directing that buildings, equipment or other things in that area be disinfected or otherwise treated, and
 - (iii) directing the seizure, treatment, and destruction of affected plants,

- (l) empowering the Department (acting through plant health officers or otherwise), in circumstances where there has been an outbreak of a specified plant pest in another Island within the Bailiwick or a neighbouring jurisdiction, to take steps aimed at minimizing the risk of that outbreak reaching Guernsey ("**preventative measures**"), including (but not limited to) –
 - (i) temporary restrictions on the landing of specified plants, plant pests and plant products, and

- (ii) making directions and restrictions relating to specified plants (including (but not limited to) directions and restrictions relating to areas where specified plants are, and the marketing, sale and transportation of specified plants),
- (m) providing for the issue of licences and permits by the Department permitting the carrying out of activities that would be otherwise controlled, restricted or prohibited, for trial or scientific or other specified purposes,
- (n) providing for plant health officers to be accompanied by persons authorised by the Department when exercising powers under the Ordinance,
- (o) providing for the payment of compensation to specified persons in specified circumstances, and
- (p) empowering the Department to levy fees and charges in relation to its functions under the Ordinance, including (but not limited to) the issue of documents.

(2) References in section 1 and subsection (1) of this section to plant pests include, unless the context otherwise requires, references to plants, soil and other material that is or may be carrying or infected with such pests; and the reference in subsection (1)(k) of this section to "affected plants" includes soil and other material that is or may be carrying or infected with plant pests.

General provisions as to Ordinances.

3. (1) An Ordinance under this Law -
 - (a) may be amended or repealed by a subsequent Ordinance hereunder, and
 - (b) may contain such consequential, incidental, supplementary, transitional and savings provisions as may appear to be necessary or expedient (including, without limitation, provision making consequential amendments to this Law and any other enactment).
- (2) Any power to make an Ordinance under this Law may be exercised -
 - (a) in relation to all cases to which the power extends, or in relation to all those cases subject to specified exceptions, or in relation to any specified cases or classes of cases,
 - (b) so as to make, as respects the cases in relation to which it is exercised -
 - (i) the full provision to which the power extends, or any lesser provision (whether by way of exception or otherwise),
 - (ii) the same provision for all cases, or different provision for different cases or classes of cases, or different provision for the same case

or class of case for different purposes,

- (iii) any such provision either unconditionally or subject to any prescribed conditions.

(3) Without prejudice to the generality of the foregoing provisions of this Law, an Ordinance under this Law -

- (a) may impose different requirements relating to the importation into, export and re-export from and transport within Guernsey of plants, plant pests and plant products depending on the country or region of origin or destination (as the case may be), including (but not limited to) whether that country or region is within the European Union,
- (b) where plants, plant products, and plant pests are to be or may be specified, may provide for them to be specified by Order of the Department,
- (c) may provide for containment measures and preventative measures to be prescribed by Order of the Department,
- (d) may, subject to subsection (4), make provision in relation to the imposition of civil penalties and the creation, trial (summarily or on indictment) and punishment of offences and may (for the avoidance of doubt) specify penalties which may be imposed by the courts,

- (e) may empower the Department, any other department of the States, and any other body or person, to make or issue orders, rules, regulations, codes or guidance, for the purposes of this Law or any Ordinance made under it,
- (f) may provide that no liability shall be incurred by any specified person or body in respect of anything done or omitted to be done in the discharge or purported discharge of any of their functions under the Ordinance unless the thing is done or omitted to be done in bad faith,
- (g) may make provision under the powers conferred by this Law notwithstanding the provisions of any enactment for the time being in force,
- (h) may make provision for the purpose of dealing with matters arising out of or related to matters set out in section 1 or 2,
- (i) may repeal, replace, amend, extend, adapt, modify or disapply any rule of custom or law,
- (j) may implement the provisions, or any provision, of any relevant convention, treaty or agreement, or any Directive or Regulation (regardless of whether these provisions are binding on or directly applicable to Guernsey),

(k) without prejudice to the generality of the foregoing, may make any such provision of any such extent as might be made by Projet de Loi, but (for the avoidance of doubt) may not provide that a person is to be guilty of an offence as a result of any retrospective effect of the Ordinance.

(4) The power conferred by subsection (3)(d) to create offences and specify penalties does not include power -

(a) to provide for offences to be triable only on indictment,

(b) to authorise the imposition, on summary conviction of an offence, of a term of imprisonment or a fine exceeding the limits of jurisdiction for the time being imposed on the Magistrate's Court by section 9 of the Magistrate's Court (Guernsey) Law, 2008^b, or

(c) to authorise the imposition, on conviction on indictment of any offence, of a term of imprisonment exceeding five years.

Orders made under powers conferred by this Law.

4. (1) Any power conferred by this Law to make Orders includes the power to make incidental, consequential, supplemental or transitional provision

and savings; and any Order made under a power conferred by this Law may be amended or revoked by a subsequent Order.

(2) Sections 3(2), 3(3)(d), (f) and (j) and 3(4) shall apply to an Order made under a power conferred by this Law as they apply to an Ordinance made under this Law, save that section 3(4) shall apply as if for paragraphs (b) and (c) there were substituted –

"(b) to authorise the imposition, on summary conviction of an offence, of a term of imprisonment exceeding six months, or a fine exceeding level 5 on the uniform scale, or both, or

(c) to authorise the imposition, on conviction on indictment of any offence, of a term of imprisonment exceeding two years."

(3) Orders made under any power conferred by this Law shall be laid before a meeting of the States as soon as is reasonably practicable after being made and shall, if at that or the next meeting the States resolve to annul them, cease to have effect, but without prejudice to anything done under them or to the making of new Orders.

Interpretation.

5. (1) In this Law, unless the context otherwise requires -

"**the Department**" means the States Commerce and Employment Department,

"**Directive**" means a Directive of the European Union and, for the avoidance of doubt, includes Council Directive 2000/29/EC^c (as amended from time to time) on protective measures against the introduction into the Union of organisms harmful to plants or plant products and against their spread within the Union,

"**enactment**" means any Law, Ordinance or subordinate legislation,

"**Guernsey**" means the Islands of Guernsey, Herm and Jethou,

"**implement**" includes the enforcement or enactment, and the securing of the administration, execution, recognition, exercise or enjoyment, in or under domestic law -

- (a) of provisions of the convention, treaty, agreement, Directive or Regulation in question, and
- (b) of any right, power, liability, obligation, prohibition or restriction created or arising, or any remedy or procedure provided for, by or under the same,

"**neighbouring jurisdiction**" means the Bailiwick of Jersey, the United Kingdom, Ireland, the Isle of Man, France, Belgium or the Netherlands,

"**officers of Customs and Excise**" means officers within the meaning of section 1(1) of the Customs and Excise (General Provisions)

(Bailiwick of Guernsey) Law, 1972^d,

"**person**" includes any body or authority,

"**plant**" means a living plant (including a tree, fungus or shrub), or a living part of a plant (including a living part of a tree, fungus or shrub), at any stage of growth; and living parts of a plant shall include –

- (a) fruit or seed,
- (b) vegetables, other than those preserved by deep freezing,
- (c) tubers, corms, bulbs or rhizomes,
- (d) cut flowers,
- (e) branches with or without foliage,
- (f) a plant or shrub that has been cut and which retains any foliage,

- (g) leaves or foliage,
- (h) a plant or shrub in tissue culture,
- (i) live pollen, and
- (j) bud wood, cuttings or scions,

"**plant pest**" means any species, strain or biotype of plant, animal or pathogenic agent which is injurious or likely to be injurious to any plant or plant product, and for the avoidance of doubt includes viruses and viroids,

"**plant products**" has the same meaning as in Article 2(1)(b) of Directive 2000/29/EC, and "**plant product**" shall be construed accordingly,

"**plant trader**" means a person in the business of buying, selling, hiring out or transporting plants,

"**Regulation**" means a Regulation of the European Union,

"**relevant convention, treaty or agreement**" means any convention, treaty or agreement having as its object the protection of plant health or the prevention of the introduction and spread of plant pests; and, for the avoidance of doubt, includes the International Plant Protection Convention^e,

"**seed**" means seed in the botanical sense other than seed not intended for planting,

"**soil**" includes other growing media, and

"**subordinate legislation**" means any regulation, rule, order, rule of court, resolution, scheme, byelaw or other instrument made under any enactment and having legislative effect.

(2) Any reference in this Law to an enactment is a reference thereto as from time to time amended, re-enacted (with or without modification), extended or applied.

Repeals.

6. The enactments specified in the Schedule are hereby repealed.

Citation.

7. This Law may be cited as the Plant Health (Enabling Provisions) (Guernsey) Law, 2014.

Commencement.

8. This Law shall come into force on the day appointed by Ordinance of the States; and different dates may be appointed for different provisions and for different purposes, and in particular, different days may be appointed for the taking effect of the repeal of particular enactments, or parts of such enactments to be specified, set out in the Schedule.

The States Trading Companies (Bailiwick of Guernsey) (Amendment) Ordinance, 2014

THE STATES, in pursuance of their Resolution of the 29th October, 2013^a, and in exercise of the powers conferred on them by sections 2 and 6 of the States Trading Companies (Bailiwick of Guernsey) Law, 2001^b and all other powers enabling them in that behalf, hereby order:-

Amendment of Ordinance.

1. For section 8 of the States Trading Companies (Bailiwick of Guernsey) Ordinance, 2001, as amended^c, substitute the following -

"Submission of accounts and annual report to the States.

8. The Committee shall cause to be submitted to the States for their consideration -

- (a) as soon as is reasonably practicable after the receipt thereof, the accounts of the States trading companies and the auditors' reports thereon, and
- (b) an accompanying report on the activities of those companies."

Extent.

2. This Ordinance has effect throughout the Bailiwick.

Citation.

3. This Ordinance may be cited as the States Trading Companies (Bailiwick of Guernsey) (Amendment) Ordinance, 2014.

Commencement.

4. This Ordinance shall come into force on the 1st May, 2014.

The Income Tax (Guernsey) (Amendment) Ordinance, 2014

THE STATES, in pursuance of their Resolution of the 11th December, 2013^a, and in exercise of the powers conferred on them by sections 75Q, 203A and 208C of the Income Tax (Guernsey) Law, 1975^b and all other powers enabling them in that behalf, hereby order:-

Amendment of 1975 Law.

1. The Income Tax (Guernsey) Law, 1975, as amended, is further amended as follows.

2. Section 75B(8)^c is repealed

3. Immediately before section 75CC^d add the following section -

"Notices under section 75B: ancillary provision.

75CB. (1) A notice under section 75B(2) shall name the taxpayer with whose liability the Director of Income Tax is concerned unless the Director of Income Tax is satisfied -

(a) that the notice relates to a taxpayer whose

identity is not known to him or to a class of taxpayers whose individual identities are not known to him, and

- (b) that the information which is likely to be contained in the documents to which the notice relates is not readily available to the Director of Income Tax from another source.

(2) A notice under section 75B(2) may also, with the express permission of a single member of the Guernsey Tax Tribunal appointed for the purpose by the President (or in his absence the Vice-President) thereof, omit the name of the taxpayer with whose liability the Director of Income Tax is concerned where that single member and the Director of Income Tax are satisfied that -

- (a) it is not necessary to name the taxpayer -
 - (i) for the purpose of obtaining the delivery, making available for inspection or furnishing of the documents or information referred to in section 75B(2), or
 - (ii) otherwise for the purpose of performing the functions of the Director of Income Tax (whether in relation to the implementation, within the meaning of section 75CC, of any approved international agreement or any provision

thereof, or otherwise), or

- (b) it is otherwise necessary or desirable to omit the name of the taxpayer (for example, in the interests of protecting confidentiality).

(3) For the avoidance of doubt the member of the Guernsey Tax Tribunal appointed under subsection (2) is not under any duty to inquire into the substantive issues of law or fact raised in or relating to the notice under section 75B(2) or the contents thereof including, without limitation, any liability or alleged liability, or the circumstances of or giving rise to any liability or alleged liability, to tax under the law of Guernsey or of any other territory.

(4) No appeal lies against a decision of the appointed member under subsection (2).

(5) A member of the Guernsey Tax Tribunal -

- (a) when exercising his functions under this section is not acting on behalf of or as a member of the Guernsey Tax Tribunal but is exercising an independent office, and
- (b) in the case of the appointed member, may not sit as a member of the Guernsey Tax Tribunal when it is hearing any appeal, question or issue connected or relating to the subject matter of the notice.

(6) A member of the Guernsey Tax Tribunal may not perform any function under this section unless he has taken an oath or made an affirmation of confidentiality under section 206(1).

(7) No liability shall be incurred by any member of the Guernsey Tax Tribunal in respect of anything done or omitted to be done in the discharge or purported discharge of any function under this section unless the thing is done or omitted to be done in bad faith or is attributable to his own fraud or wilful misconduct.

(8) The Policy Council may determine the costs, fees, expenses and allowances payable to a member of the Guernsey Tax Tribunal in respect of the performance of any functions under this section."

4. After section 206(1)(b) insert the following paragraph -

"(ba) is a member of the Tribunal, for the purposes of exercising the functions of an appointed member under section 75CB (provided that a person who, immediately prior to the date of commencement of the Income Tax (Guernsey) (Amendment) Ordinance, 2014, was a member of the Tribunal and who, before that date, had taken the oath required to be taken by such a member under paragraph (b), shall be deemed to have taken the oath required by this paragraph), or".

Citation.

5. This Ordinance may be cited as the Income Tax (Guernsey) (Amendment) Ordinance, 2014.

Commencement.

6. This Ordinance shall come into force on the 30th April, 2014.

**The Electronic Transactions
(Obligation to use Electronic Form)
(Guernsey) Ordinance, 2014**

THE STATES, in pursuance of their Resolution of the 11th December, 2013^a, and in exercise of the powers conferred on them by sections 9(2), 21 and 23(1) of the Electronic Transactions (Guernsey) Law, 2000, as amended^b and all other powers enabling them in that behalf, hereby order:-

Circumstances in which electronic form and electronic means are obligatory.

1. (1) For the purposes of section 9(2) of the Electronic Transactions (Guernsey) Law, 2000, as amended ("**the Law**"), where any document specified in subsection (2) is required or permitted to be given by or on behalf of any person to the Guernsey Financial Services Commission ("**the Commission**"), the document shall be given -

- (a) in such electronic form and by such electronic means as the Commission may require, whether in any particular case or class of cases or generally, or
- (b) in such non-electronic form and by such non-electronic means as the Commission may in its absolute discretion determine in any particular case or class of cases.

(2) The documents referred to in subsection (1) are applications, requests, returns, records, reports, accounts, submissions, statements, notices, notifications, forms, letters, schedules, personal questionnaires, personal declarations and other documents required or permitted to be given by or under the relevant Laws.

Amendment of Law.

2. For section 3 of the Law substitute the following section -

"Declarations and statements.

3. (1) A declaration or statement made under oath or by affirmation shall not be denied legal effect, validity, enforceability or admissibility solely because it is in electronic form.

(2) A statutory declaration or other declaration or statement made otherwise than under oath or by affirmation shall not be denied legal effect, validity, enforceability or admissibility solely because it is in electronic form."

3. For section 8(1)(f) of the Law substitute the following paragraphs -

"(f) a declaration or statement to be made under oath or by affirmation, a sworn or affirmed declaration or statement in electronic form satisfies the law, or

(g) a statutory declaration or other declaration or statement to be made otherwise than under oath or by affirmation, a statutory declaration or other declaration or statement in electronic form satisfies the law."

4. In section 22(1) of the Law after the definition of "signature in electronic form" insert the following definitions in the appropriate places -

"**declaration**" includes, for the avoidance of doubt, a declaration required or permitted to be made by or under or otherwise for the purposes of an enactment or statutory instrument,"

"**statutory declaration**" means a declaration made in accordance with the provisions of an Order of the Royal Court made on the 23rd of April 1838^c,".

Interpretation.

5. (1) In this Ordinance -

"**Commission**" means the Guernsey Financial Services Commission,

"**given**" means given, produced, served, sent or delivered (whatever expression may be used to describe the act),

"**Law**" means the Electronic Transactions (Guernsey) Law, 2000,

"**relevant Laws**" means -

- (a) the Financial Services Commission (Bailiwick of Guernsey) Law, 1987,
- (b) the Protection of Investors (Bailiwick of Guernsey) Law, 1987,

- (c) the Banking Supervision (Bailiwick of Guernsey) Law, 1994,
- (d) the Companies (Alderney) Law, 1994,
- (e) the Criminal Justice (Proceeds of Crime) (Bailiwick of Guernsey) Law, 1999,
- (f) the Regulation of Fiduciaries, Administration Businesses and Company Directors, etc (Bailiwick of Guernsey) Law, 2000,
- (g) the Insurance Business (Bailiwick of Guernsey) Law, 2002,
- (h) the Insurance Managers and Insurance Intermediaries (Bailiwick of Guernsey) Law, 2002,
- (i) the Registration of Non Regulated Financial Services Businesses Law, 2008,
- (j) the Companies (Guernsey) Law, 2008,
- (k) the Prescribed Businesses (Bailiwick of Guernsey) Law, 2008,
- (l) any other enactment or statutory instrument prescribed for the purposes of this section by regulations of the Commission (and section 21 of the Law shall apply to

regulations of the Commission under this paragraph as it applies to an Order of the Committee under the Law).

(2) Any reference in this Ordinance to an enactment or statutory instrument is a reference thereto as from time to time amended, re-enacted (with or without modification), extended or applied.

Citation.

6. This Ordinance may be cited as the Electronic Transactions (Obligation to use Electronic Form) (Guernsey) Ordinance, 2014.

Commencement.

7. This Ordinance shall come into force on the 1st May, 2014.

**The Severe Disability Benefit and Carer's Allowance
(Guernsey) Law, 2013 (Commencement) Ordinance, 2014**

THE STATES, in exercise of the powers conferred on them by section 7 of the Severe Disability and Carer's Allowance (Guernsey) Law, 2013^a, hereby order:-

Commencement of Law.

1. The Severe Disability Benefit and Carer's Allowance (Guernsey) Law, 2013 shall come into force on the 1st May, 2014.

Citation.

2. This Ordinance may be cited as the Severe Disability Benefit and Carer's Allowance (Guernsey) Law, 2013 (Commencement) Ordinance, 2014.
