**THE STATES**, in pursuance of their Resolution of the 26<sup>th</sup> November, 2014<sup>a</sup>, and in exercise of the powers conferred on them by section 14 of the Disclosure (Bailiwick of Guernsey) Law, 2007<sup>b</sup>, hereby order:-
