#### GENERAL ELECTION – ST PETER PORT NORTH POLLING STATIONS

#### Dear Sir,

- 1. On the 25<sup>th</sup> June 2015 (Billet d'État XI of 2015) the States approved, with amendments, a policy letter from the Committee regarding the General Election in 2016. *Inter alia* that policy letter established new locations for the polling stations in St Saviour in the West district but all other polling stations remained in the locations used in the 2012 General Election.
- 2. Under the terms of Article 26(3) of the Reform (Guernsey) Law, 1948, as amended, the Constables of a parish are obliged to establish polling stations in accordance with Resolutions of the States. For many years the polling stations in St Peter Port North have been established at St John's Church Hall and Beau Séjour Leisure Centre. St John's Church Hall was not available for the recent by-election and it has now emerged that unfortunately it will not be available for the General Election on the 27<sup>th</sup> April 2016 either. The Registrar-General of Electors has investigated the matter and looked at other possible sites. He has concluded that the polling station which would have been established at St John's Church Hall should instead be established at the Princess Royal Performing Arts Centre with effect from the 2016 General Election. Performing Arts Centre has plenty of parking and easy, level access for the less mobile. It is further from Beau Séjour which makes it more convenient for those electors who do not live near the Leisure Centre. It is suitable for use as a polling station. The Committee unanimously agrees with his suggestion and therefore recommends the States to make a new Resolution under the terms of Article 26(3) of the Reform (Guernsey) Law, 1948, as amended, to change where the St Peter Port North polling stations should be established.

#### CONSULTATION / RESOURCES / NEED FOR LEGISLATION

3. The Law Officers have not identified any reason in law why the proposals set out in this policy letter cannot be implemented.

4. The Committee has liaised with the Constables of St Peter Port and the Registrar-General of Electors about this matter and they are content to establish the polling stations at these two locations. The Registrar-General is satisfied that there would be no resource implications arising from having the polling station in a different location to that originally planned.

#### RECOMMENDATIONS

5. The States' Assembly & Constitution Committee recommends the States, in accordance with Article 26(3) of the Reform (Guernsey) Law, 1948, as amended, to establish the polling stations for the St Peter Port North district at Beau Séjour Leisure Centre and the Princess Royal Performing Arts Centre.
